### HEARING PROCEDURES FOR RESIDENTIAL RELEASES OF OPEN SPACE

In appearing before the Planning, Building and Zoning Committee, the presentation justifying the request is the responsibility of the homeowner. Presentations should begin with a description of what you wish to construct and why it is necessary to obtain a release of open space. You should be prepared to respond to questions regarding alternatives that would not require a release of open space.

The Planning, Building and Zoning Committee hearing will conclude with a vote. This vote, however, does not conclude the release of open space process and does not allow you to obtain a building permit. The Planning, Building and Zoning Committee is a recommending body and all Planning, Building and Zoning recommendations are forwarded to the Village Board for final action. The Village Board meets the first and third Monday of every month. At the conclusion of the Planning, Building and Zoning hearing, the Planning, Building and Zoning Committee should provide you with the exact date when your request will be forwarded to the Village Board for final action.
