Mrs. Musiala stated that during the month of November 2015 cash disbursements and transfers-out exceeded cash receipts and transfers-in for the operating funds by \$5,217,661. After including these receipts and disbursements, the balance of cash and investments for the operating funds is \$28.5 million. For all of the Village funds, cash disbursements and transfers-out exceeded cash receipts and transfers-in by \$8,236,161 primarily due to annual debt service payments. Overall, the total for cash and investments for all funds decreased to \$189.2 million.

- 2. Massage and tanning services are only permitted in designated rooms indicated on the approved building/tenant layout (approximately 88 square feet each).
- 3. Formalized outdoor activities shall be prohibited.

Mr. Abuaita also stated that all of the private rooms would have emergency devices in them, he explained that there should not be a noise issue with neighboring businesses because of the layout in his business, that he does not have any other Anytime Fitness locations and that he would be the manager.
