- I. Call to Order. Meeting called to order at 9:37 am.

III. Minutes.

- IV. Announcements/Communications: Membership Dues invoice from IPPFA, Matt Fijalkowski will research IPPFA for next meeting. Brian Schroeder, Attorney, sent communication regarding attorney services.
- V. President's Report. Nothing to report at this time.
- VI. Secretary's Report.
 - Got pension computer from past secretary. In the process of getting pension files moved from Station 21 to Station 24. Checked on PO Box and it has been closed since 2012. All pension board mail will be directed to Village Hall and redirected to the Board.

VII. Treasurers Report/Finance Report

1. Review/discussion. Employer contribution will be around 99% of what was budgeted. Pension expenditures will come in about \$101,000 over budget because they don't anticipate retirees. In 2012 72.7%, 70.9% funded in 2013, the change in the assumption table brought it down and increased the liability and unfunded contribution. Between now and 2040 it has to be made up. Not unique to Hoffman, across the board it will be a

- continuing issue. Scott Brandt said there is a required amortization schedule, the board would like to see that.

- 3. Vote to approve outstanding invoices. Invoice from Barbara Bell \$2,636.16 fees related to Rolowicz and McDounga. VIII. Investment Report

- 1. Mitchell, Vaught & Taylor's Quarterly Report. All account names have been updated. MVT was verified as Gibbs Complaint. Page 4, asset allocation, close to target for fixed and equities. Equity portion target is 38%, at 40% right now. One area where it is under allocated is in real estate, target is 5%, the recommendation is to continue to underweight real estate for the time being. Fund is up 16.5%. Fund for the quarter is up 4.47%. Motion to accept report by Jimmy Oskroba, second by Bob Orr. All in favor, aye.
- Discussion. Bill Yocius updated investment policy to reflect changes that have been made, move targets from body of investment policy to the appendix to make changes easier. Also changed maximum and minimums to match the state statute.
- IX. Attorney's Report. Tom McDonough and Gerry DuMelle are the only two firefighters on disability pensions under 50 needing annual exams. McDonough was examined on Dec 19, found still disabled. DuMelle's annual exam is scheduled for January 30. Application for line of duty disability pension received from Tom Tyrrell. New board members need to take their 30 hours of training.
