Mitchell, Vaught & Taylor's Quarterly Report. Overweight in real estate and domestic stocks, etc. Oak Mark underperforming their target, keeping a close eye on them. Executive summary through end of June. Over \$1 million for the period. \$682,000 annualized net return, over our 6.75 actuarial return. Net investment gain over last 3 years \$15.8 million. Half of total return in fixed income. \$155 million total fund, higher than target. Vanguard was replaced by T. Rowe Price Small Cap fund which did well. International sector underperformed. 1.6 versus 1.4 for the target, being underweight in international helped since it underperformed. Oak Mark Intl -755 for the quarter. REIT below benchmark because Brookdale properties had some issues, YTD still beating target. S&P 15 Healthcare had a lower quarter but still beating target YTD.
