PURPOSE: To replace current video editing system with SAN network storage.

BACKGROUND: The approved 2016-2021 Capital Improvements Program included the

replacement of the current video editing and storage system at a cost of \$50,000. The current editing and storage system is seven years old and past

the average life expectancy of the equipment.

DISCUSSION: The expected life cycle of computer based systems is five years. The current systems are lagging and freezing. They are not compatible with

today's video file standards. It has become increasingly difficult to find companies that will maintain the system due to its age. The 2017 budget includes \$50,000 for the replacement of the editing and storage system.

At the time the current editing system was purchased, the Village was editing Standard Definition (4x3) video. We then began editing HD (16x9) video at 1440x1080 pixels. The HD standard has since increased to 1920x1080 pixels. The current editing system has problems processing video files shot at 1920x1080.

HD video is now being replaced by 4K video, which is 4096×2160 pixels. While it will probably be some time, if ever, that the Village's cable channel becomes 4K, it would be wise to have that capability. The cameras purchased last year and the editing and storage system budgeted for replacement this year are both HD and 4K compatible, the same way the last systems were SD and HD compatible.

The Village publicized a notice of bid in the January 12, 2017 *Daily Herald* for a two seat video editing system with SAN network storage. One bid was received.
