Fixed income up 1.07%, Equities up 3.42%, total fund up 2.5%. Suggesting removing REITs as a separate target, not as an investment. Change the target and remove the REITS as separate from the Russell 3000. Review Investment Policy as next meeting and think about changing the target. Overweight Rothchild and move into Vanguard Growth Fund, dollar value to be discussed at next meeting.
