Mrs. Musiala stated that during the month of September 2017, for operating funds cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$4.41 million, primarily due to receipt of 2017 Bond Proceeds. After including these receipts and disbursements, the balance of cash and investments for the operating funds is \$44.9 million.

For the operating, Debt Service and Capital Projects funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$4.30 million, primarily due to receipt of 2017 Bond Proceeds.

For the Trust Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$1.13 million, primarily due to investment activity in the Pension funds.

The total for cash and investments for all funds increased to \$231 million.

Request by McMaster/Faganel Custom Homes LLC (applicant) and Anthony Parato (owner for a variation from Section 9-3-6-K-2 of the Zoning Code to permit the construction of a 848 square foot attached garage instead of the 750 maximum square feet allowed by code at 1694 and 1700 Pondview Drive in Devonshire Woods Estates.

Trustee Mills asked what the reason was for the larger garage. Chairperson stated that they have a lot of cars and that they would possibly have to put in ramps for elderly relatives.

7.D. Request by Itasca Bank & Trust Co., Trust #12551 (owner) and Stonegate Properties, Inc. (applicant) for a site plan amendment for a second drive-thru on the property located at 2061-2071 N. Barrington Road.

Discussion

George M. Moser, owner, stated that he didn't know what the problem was.

Trustee Stanton asked if they ever had complaints from Starbuck's when the bank had the drive-thru, Mr. Moser replied no.

Trustee Mills asked if any of the conditions had changed, Mr. Gugliotta replied no.

Doug Altenberger said that they agree to all of the conditions.

There was discussion about traffic having to crisscross through the lanes.

Wendell Hollan, CBRE, stated that they would install directional signage for the drive thru merge. Mr. Gugliotta states that condition #3 won't allow occupancy unless this issue is resolved.

Motion by Trustee Mills, seconded by Trustee Pilafas, to add stronger verbiage in condition #3. Voice vote taken. All Ayes. <u>Motion carried.</u>

Trustee Mills asked if there was a current shared parking agreement in place.

They have one but it doesn't appear to include this piece of property, therefore a new agreement must be completed and recorded before occupancy is approved as stated in Condition #1.

George Moser stated that he feels like we are condemning this building.

Chairperson Combs stated that the traffic study for the queuing was done at the window and she feels that the backup will happen at the message board.

(applicant) for a variation under Section 9-3-8-M-10-e-(1) of the Zoning Code to permit a third (11 square foot) menu board sign and an additional ground sign (3 square foot speaker post) on the property located at 2061-2071 N. Barrington Road.

- **7.F.** Request of Poplar Creek L.L.C. (owner) and Stonegate Properties, Inc (Applicant) to consider an extension of a special use amendment under Section 9-8-2-C-9 of the Zoning Code to allow retention of an outdoor patio on the west side of The Stonegate Conference and Banquet Centre building located at 2401 W Higgins Road, subject to following conditions:
- 1. All conditions of the banquet and conference facility special use approval (Ordinance No. 3377-2000) shall remain in effect. The patio shall remain in conformance with the previously approved site plan amendment for the patio expansion.
- 2. The petitioner shall manage event scheduling and attendance to ensure that parking demand does not exceed the onsite parking supply.
- 3. The hours of operation for the tent shall be limited to 5:30am to 12:30am.
- 4. The tent and patio shall remain in conformance with all building and fire codes. Any outstanding building and fire issues with the tent structure shall be resolved as directed by the Building and Fire Departments.
- 5. All outstanding property maintenance violations shall be corrected by November 15, 2017.
- 6. This special use shall be valid for five (5) years from the Village Board approval, at which time the petitioner may apply for a 5 year extension.

Discussion

Trustee Mills asked if the repairs were completed by November 15th.

Mr. Altenberger and Charles Baptiste, GM Stonegate, stated that the repairs would be finished sometime in December.

Trustee Gaeta asked if the violations were taken care of. Mr. Gugliotta replied that there has been some progress.

Mr. Altenberger and Mr. Baptiste stated that many were completed.

Trustee Stanton asked to go through the list to see what was completed and what wasn't.

- #1 the pavement in the east and south lots need a lot of attention. Mr. Altenberger responded that they wouldn't be able to get that done before the asphalt plants close.
- #2 the emergency exit in the back of the building stairs are rusted away. Mr. Altenberger stated that the upper levels have been repaired.
- #3 46 shade trees were removed and not replaced. Mr. Altenberger responded that they replaced them with low grow sumac trees and ornamental grasses. Mr. Gugliotta stated that they didn't follow the code requires trees replacements and didn't ask for a variance.
- #4 the retaining wall by the fountain is falling down and fountain in disrepair.
- #5 miscellaneous painting, rusted areas and cracked curbing all need to be taken care of.

Trustee Mills asked if the retaining wall could be repaired without fixing the fountain. Mr. Altenberger responded that they will work with Barrington Pools to fix the wall.

Trustee Pilafas stated that he didn't get a sense of collaboration regarding the issues with the site.

Trustee Mills asked how many events do they have booked in the tent. Mr. Baptiste responded 30 in the next 12 months with 4 in December and 3 in January.

Mr. Altenberger agreed to the July 1, 2018 deadline.

Motion by Trustee Pilafas, seconded by Trustee Gaeta, to extend the special use until July 1, 2018 at that point consideration may be granted for a longer extension upon compliance with all if the violations, also the dates in condition #5 and #6 will be corrected to reflect the new timeline set.
