

Portfolio Strengths

Fixed - With the yield curve narrowing in the period due to Fed action on the short end and a lack of meaningful inflation for the long end, bond prices in the period were generally weaker.

Both fixed income managers beat their respective targets with investment grade corporates, TIPS and longer duration government mortgages helping both managers.

Equity - Similar to most of the year, the growth sector continues to lead all equity markets, both domestic and international, although every manager again showed positive quarterly performance. The two smaller cap growth funds, one domestic and one international had very good quarters as did large core separate account manager Rothschild.

Weaknesses

Fixed - With the yield curve narrowing mostly due to the short and intermediate term rates moving higher, the prices of those bonds tended to be weaker, regardless of sector.

Equity - In general, the value sector of the equity market was the weakest in the quarter meaning both the smid and REIT managers underperformed their more growth focused counterparts.

Also, the previous quarters' best two managers (T Rowe Health and Oakmark) were the weakest of this periods returns.


Strategies

Portfolio - Despite the length of the current domestic economic recovery, generally positive incoming data makes a domestic recession appear unlikely in the near term. Alternatively, some international markets are showing signs of slowing, but even that is not universal across all markets. The combination of Fed action and the lack of any significant inflationary signs, means the yield curve will continue to narrow. In addition to increasing the overnight rate, the Fed has indicated a desire for another three increases in 2018 and have begun their balance sheet reductions. Similar to last quarter, in fixed income we continue to prefer a slightly shorter than target duration combined with higher quality corporate debt. In equities, we'll stay close to target weights, and look to add out-performance by your active managers.



4Q2017

3rd quarter U.S. GDP reported at 3.3%. Employment remains strong with wage gains and an increase in aggregate hours worked. Consumer activity and business investment contributed to growth. GDP has been ramping up throughout 2017.

Jerome Powell has been nominated as Fed Chairman to succeed Janet Yellen in February 2018. Mr. Powell has different credentials than recent chairpersons in that he is an attorney, not an economist and has served as a Fed Governor since 2012. This marks the first time in 4 decades that a new president did not ask the current Fed chair (Yellen) to stay for a 2nd term.

We conducted due diligence with several funds during the Schwab Impact conference in Chicago including Oakmark, T Rowe Price and Oppenheimer. We also attended a due diligence meeting at the American Funds headquarters.

The Fed voted to raise rates again at their meeting December 12th. Members expressed confidence in the economy but would like to see inflation tick up.

3Q2017

2nd quarter U.S. GDP revised up to 3.1%. Consumer activity and business spending added to growth. Initial unemployment claims have remained below the key 300,000 threshold for 134 weeks, the longest stretch since 1970.

MVT has been hired by the West Chicago Firefighters pension fund.

MVT staff members presented at the IPPAC training seminars in LaSalle and Schaumburg on the topics of bond trading and Cyber Security with best practices for pension trustees to protect data.

Staff members conducted due diligence with MFS Investments, AMG Funds, Oppenheimer, Alliance Bernstein, American Funds, Ivy Funds, Goldman Sachs.

Staff members attended educational seminars on Cyber-security, Regulatory Updates, Morningstar ETF Conference, SEC Custody Rule.

The Fed indicated the likelihood for one more rate increase this year.

Timing of Performance Information

It is quite common to have inaccurate information regarding index returns as well as pricing and transaction data from custodians at the end of a reporting period. Often, these inaccuracies are cleared up within the first week or two of the following period. Our pension clients should be aware that quarter-end data reported within the first two weeks of a new quarter has a higher likelihood of inaccuracy. We do our best to weed out these problems, but there may be times when we feel it necessary to leave out the performance for the final month of a quarter.

Index Returns

Per the investment policy, the benchmark for the total portfolio is 40% Barclays Intermediate Aggregate Index and 60% of an Equity Blended Index.

The equity blended index is 58.3% S&P 500, 33.3% MSCI EAFE, and 8.34% Wilshire REIT Index. As of January 1, 2016 the equity blended index was changed to 58.3% Russell 3000, 33.3% MSCI All Country World Index xUSA, and 8.34% Wilshire REIT Index.

The benchmark for the William Blair and Company fixed income managed account was the Barclays Intermediate Aggregate Index from 01/31/2013 (inception) until 08/13/2014. Since then, the benchmark is the Barclays Aggregate Bond Index.
