Asset Allocation changes: moved \$4 million to Vanguard Growth Fund from Rothschild, \$1.2 million from Adelante to all international managers equally and remaining to the Russell 3000 iShare. Moved all cash to the Schwab Money Fund from Cash Sweep Fund. No recommended changes moving forward. Ending value now over \$80 million, 2017 dollar gain was \$9.8 million.  - Status of Trustee Training.
