Mrs. Musiala stated that during the month of August 2018, for Operating funds cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$541,918, primarily due to receipt of property taxes. After including these receipts and disbursements, the balance of cash and investments for the operating funds is \$47.9 million.

For the Operating, Debt Service and Capital Projects funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$1.26 million, primarily due to receipt of property taxes and budgeted operating transfers.

For the Trust Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$11.9 million, primarily due to receipt of property taxes.

The total for cash and investments for all funds decreased to \$245.3 million.



### **AUDIENCE COMMENTS**

### **FINDING**

The Planning & Zoning Commission heard from the property owner who explained that he is requesting a variation to construct an approximately 206 square feet garage, as opposed to the minimum required 440 square feet garage, to provide a secure and safe place to store his motorcycle that have been tampered with multiple times over the years. The property owner explained he did look into building a garage that meets current code requirements, however, doing so would result in the garage encroaching into the required side-yard setback and the costs associated with building conforming garage would be a burden.

Staff informed the Commission due to the existing footprint of the property, the property owner would have to either way request a variation for a side-yard setback or from the minimum garage size requirement. Staff informed the reason for the minimum garage size variation is because it would not have an adverse impact on the neighboring property since it would maintain the minimum side-yard setback while bringing the property closer to conformity. Staff further informed the Commission that the property owner has a shed in the rear yard for storage purposes, so between the shed and the new attached garage the intent of the minimum garage size requirement would be met.

One Commissioner stated and asked that other homes in the area have built detached garages behind the house and if that would be an option for the property owner. Property owner stated that there is steep grade

change in his backyard that would make it difficult and costly to build a detached garage since the backyard is not level.

# INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF HOFFMAN ESTATES AND THE TOWNSHIP OF SCHAUMBURG REGARDING MOTOR FUEL SERVICE

This Intergovernmental Agreement ("Agreement"), entered into this day of
, 2018, by and between the Village of Hoffman Estates (the
"Village") and the Township of Schaumburg ("Schaumburg Township"), under the
authority granted to them pursuant to Section 10 of Article VII of the Illinois Constitution
of 1970, the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 et. seq., and all
other applicable authority, under which the parties are authorized to enter into this
Agreement.

### WITNESSETH:

WHEREAS, the Village and Schaumburg Township agree and desire to enter into this Agreement for motor fuel service; and

WHEREAS, the Village and Schaumburg Township believe it is in their respective best interests to enter into this Agreement; and

WHEREAS, the Village and Schaumburg Township agree that matters provided in this Agreement will be dealt with efficiently by entering into this Agreement.

NOW, THEREFORE, it is hereby agreed and understood by the parties that:

- 1. The Village agrees to provide motor fuel to Schaumburg Township at the Village's Public Works Vehicle Maintenance Facility at 2405 Pembroke Avenue.
- 2. Schaumburg Township agrees to pay to the Village an initial start-up fee of \$200 to cover chip keys and accounting set-up costs prior to the commencement of the motor fuel service, the actual cost of the motor fuel and an additional fourteen cents (\$.14) a gallon to cover accounting costs, pump maintenance cost and cost of additional fuel deliveries to be paid within thirty (30) days of invoice.

3. Each party hereto agrees to waive all claims against each other thereto for any loss, damage, personal injury or death occurring in consequence of the performance of this Intergovernmental Agreement, provided, however, that such claim is not a result of gross negligence or willful misconduct by a party hereto or its personnel. 4. This Agreement shall be effective from and after . 5. This Agreement may be terminated by either party upon 120 days prior written notice to the other. IN WITNESS WHEREOF, the Village and Schaumburg Township have caused this Agreement to be executed on their behalf by their respective officials, pursuant to proper authorization of their respective governing bodies, on the dates noted herein. AN ORDINANCE AMENDING SECTION 7-2-2, SALE OF TOBACCO PRODUCT OR ELECTRONIC SMOKING DEVICES TO MINORS PROHIBITED,
SECTION 7-8-13, PROHIBITION OF CRIMINAL PUBLIC NUISANCES; ABATEMENT THEREOF,
SECTION 7-13-1, PENALTY, AND
SECTION 8-7-16, ITEMS DESIGNED OR MARKETED FOR USE WITH CANNABIS OR DRUGS, OF THE HOFFMAN ESTATES MUNICIPAL CODE

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

Section 1: That Section 7-2-2, SALE OF TOBACCO PRODUCT OR ELECTRONIC SMOKING DEVICES TO MINORS PROHIBITED, of Chapter 7, OFFENSES AND PUNISHMENT, of the Hoffman Estates Municipal Code, be and is hereby amended to read as follows:

### Section 7-2-2. <u>SALE OF TOBACCO PRODUCT OR ELECTRONIC SMOKING DEVICES</u> TO PERSONS UNDER 21 YEARS OF AGE PROHIBITED

- A. Prohibited Sales, Delivery or Possession.
  - 1. It shall be unlawful for any person under 21 years of age to buy any Tobacco Product or Electronic Smoking Device as defined in Section 8-7-15 of the Municipal Code.
  - 2. It shall be unlawful for any person under 21 years of age to possess any Tobacco Product or Electronic Smoking Device.
  - 3. It shall be unlawful for any person to sell, buy for or furnish any Tobacco Product or Electronic Smoking Device to any person under 21 years of age.
- B. Signs. Signs informing the public of the age restrictions provided for herein shall be posted by every Tobacco Product or Electronic Smoking Device licensee at or near every display which offers Tobacco Products or Electronic Smoking Devices for sale. The text of such signs shall be in red letters on a white background, said letters to be at least one-half (1/2) inch high. Each such sign shall be plainly visible and shall state:

"THE SALE OF TOBACCO PRODUCTS AND ELECTRONIC SMOKING DEVICES TO PERSONS UNDER TWENTY-ONE YEARS OF AGE IS PROHIBITED BY LAW"

- C. License Revocation. The business license of any Tobacco Product or Electronic Smoking Device dealer issued under Section 8-7-15 of this Municipal Code shall be revoked upon a third conviction of Section 7-2-2-A-3 in any 12-month period.
- <u>Section 2</u>: That Section 7-8-13, <u>PROHIBITION OF CRIMINAL PUBLIC</u>
  <u>NUISANCES: ABATEMENT THEREOF</u>, of Chapter 7, <u>OFFENSES AND PUNISHMENT</u>, of the Hoffman Estates Municipal Code, be and is hereby amended by amending Sub-Section A-1-m to read as follows:

### Section 7-8-13. <u>PROHIBITION OF CRIMINAL PUBLIC NUISANCES</u>; ABATEMENT THEREOF

m. Any offense defined and prohibited by Act 685 (Tobacco Accessories and Smoking Herbs Control Act) of the Criminal Code, 720 ILCS 685/1 et seq., or any violation of Section 7-2-2 (tobacco sales and electronic smoking devices to persons under age 21) of the Hoffman Estates Municipal Code.

<u>Section 3</u>: That Section 7-13-1, <u>PENALTY</u>, of Chapter 7, <u>OFFENSES AND PUNISHMENT</u>, of the Hoffman Estates Municipal Code, be and is hereby amended by amending Sub-Section D-1 to read as follows:

1. In the event that said payment is made prior to the Municipal Code Administrative Adjudication Hearing, the following amounts shall be accepted as a settlement, any debt or fee owed the Village plus:

Persons under the age of 21 in Possession of Tobacco Product or
Electronic Smoking Device ......\$250.00
Sale of Tobacco to Product or Electronic Smoking Devices
ToPersons under the age of 21.....\$500.00

<u>Section 4</u>: That Section 8-7-16, <u>ITEMS DESIGNED OR MARKETED FOR USE WITH CANNABIS OR DRUGS</u>, of Chapter 8, <u>LICENSES</u>, of the Hoffman Estates Municipal Code, be and is hereby amended to read as follows:

### Section 8-7-16. <u>ITEMS DESIGNED OR MARKETED FOR USE WITH CANNABIS OR DRUGS</u>

- A. License Required It shall be unlawful for any person or persons as principal, clerk, agent or servant to sell any items, effect, paraphernalia, accessory or thing which is designed or marketed for use with illegal cannabis or drugs, as defined by Illinois Compiled Statutes, without obtaining a license therefor. Such licenses shall be in addition to any or all other licenses held by applicant.
- B. Applicant Application to sell any item, effect, paraphernalia, accessory or thing which is designed or marketed for use with illegal cannabis or drugs shall, in addition to requirements Section 8-1, be accompanied by affidavits by applicant and each and every employee authorized to sell such items that such person has never been convicted of a drug-related offense.
- C. Persons under 21 It shall be unlawful to sell or give items as described in Section 8-7-16-A in any form to any person under 21 years of age.
- D. Records Every licensee must keep a record of every item, effect, paraphernalia, accessory or thing which is designed or marketed for use with illegal cannabis or drugs which is sold and this record shall be open to the inspection of any police officer at any time during the hours of business. Such record shall contain the name and address of the purchaser, the name and quantity of the product, the date and time of the sale, and the licensee or agent of the licensee's signature, such records shall be retained for not less than two years.

#### VILLAGE OF HOFFMAN ESTATES

AN ORDINANCE AMENDING SECTION 8-3-22, NUMBER OF LICENSES OF ARTICLE 3, ALCOHOLIC LIQUORS, OF THE HOFFMAN ESTATES MUNICIPAL CODE (DECREASE IN NUMBER OF CLASS "A" LICENSES, PHO CHOPSTICKS, 2 W. GOLF CENTER, HOFFMAN ESTATES)

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

<u>Section 1</u>: That Section 8-3-22, <u>NUMBER OF LICENSES</u>, of the Hoffman Estates Municipal Code be and the same is hereby amended to read as follows:

The number of licenses issued to persons for the sale of alcoholic liquors by the Village of Hoffman Estates shall be limited to sixty (60) Class "A" licenses, two (2) Class "AA" licenses, fifteen (15) Class "B" licenses, unlimited Class "C" licenses, four (4) Class "D" licenses, two (2) Class "DD" licenses, one (1) Class "F" license, one (1) Class "G" licenses, unlimited Class "H" licenses, one (1) Class "I" license, eighteen (18) Class "LC" licenses, one (1) Class "AC" license and eight (8) Class "J" licenses.

Section 2: That any person, firm or corporation violating any of the provisions of this Ordinance shall be subject to a fine of not less than Ten Dollars (\$10.00) nor more than Five Hundred Dollars (\$500.00) for each offense, and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

Section 3: That the Village Clerk is hereby authorized to publish this ordinance in pamphlet form.

<u>Section 4</u>: That this Ordinance shall be in full force and effect immediately from and after its passage and approval.

### VILLAGE OF HOFFMAN ESTATES

AN ORDINANCE PROPOSING THE DESIGNATION OF A REDEVELOPMENT PROJECT AREA AND PROPOSING THE APPROVAL OF A REDEVELOPMENT PLAN AND PROJECT FOR THE LAKEWOOD CENTER REDEVELOPMENT PROJECT AREA, CONVENING A JOINT REVIEW BOARD AND CALLING A PUBLIC HEARING IN CONNECTION THEREWITH

WHEREAS, pursuant to the Tax Increment Allocation Redevelopment Act, as supplemented and amended (the "TIF Act"), the President and Board of Trustees (the "Corporate Authorities") of the Village of Hoffman Estates, Cook and Kane Counties, Illinois (the "Municipality"), is considering that it is advisable and in the best interests of the Municipality and certain affected taxing districts that the Municipality consider the designation of a redevelopment project area and the approval of a redevelopment plan and project (the "Redevelopment Plan") and (the "Project") for the redevelopment project area proposed to be known as the Lakewood Center Redevelopment Project Area (the "Redevelopment Project Area") as further described in Exhibit "A" attached hereto; and

WHEREAS, pursuant to Section 11-74.4-4.2 of the TIF Act, the Municipality is required to create an interested parties registry for activities related to each redevelopment project area within its territory, including the Redevelopment Project Area, to adopt reasonable registration rules, and to prescribe requisite registration forms for residents and organizations active within the Municipality that seek to be placed on said interested parties registry, and the Corporate Authorities have heretofore, and it hereby expressly is, determined that the Municipality has adopted such registration rules and prescribed such requisite registration forms and give public notice thereof; and

WHEREAS, on October 25, 2018, the Municipality announced the availability of the redevelopment plan and project for the proposed Lakewood Center Redevelopment Project Area, with the proposed Redevelopment Plan containing an eligibility study for the proposed Lakewood Center Redevelopment Project Area (hereinafter referred to as the "Eligibility Study") addressing the basis of the tax increment financing eligibility of the area proposed for the Redevelopment Project Area; and

WHEREAS, pursuant to Section 11-74.4-4.5 of the TIF Act also requires that the Municipality convene a joint review board and conduct a public hearing prior to the adoption of ordinances designating and approving a redevelopment plan and project, at which hearing any interested person or affected taxing district may file with the Village Clerk written objections to and may be heard orally with respect to the Redevelopment Plan and Project; and

WHEREAS, Section 11-74.4-5 of the TIF Act further requires that the time and place of such public hearing be fixed by ordinance or resolution adopted by the Corporate Authorities; and

WHEREAS, the TIF Act further requires that at least 10 days prior to adopting such ordinance or resolution fixing the time and place of a public hearing, the Municipality must make available for public inspection the Redevelopment Plan along with the name of the person to contact for further information, and the same shall be sent within a reasonable time after adoption to the affected taxing districts by certified mail; and

WHEREAS, the TIF Act requires that notice of the public hearing be given by publication and mailing; and

WHEREAS, the Corporate Authorities have herein determined that it is advisable to convene a joint review board and hold a public hearing to consider the proposed designation and approval of the proposed Redevelopment Plan and Project; and

WHEREAS, the Corporate Authorities hereby expressly find that the Redevelopment Plan and Project does not contain 75 or more inhabited residential units and will not displace residents from 10 or more inhabited residential units.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

<u>Section 1</u>: Preambles. The Corporate Authorities hereby adopt by reference the foregoing preamble clauses as if fully set forth herein.

<u>Section 2</u>: Redevelopment Plan and Project Designation and Approval. The designation and approval of the Redevelopment Plan and Project, is hereby proposed.

Section 3: Interested Parties Registry Created. There is hereby created an interested parties registry (the "Registry") for the Redevelopment Project Area. The Village Clerk is hereby expressly authorized and directed to maintain such Registry for the Redevelopment Project Area. The Municipality shall print in a newspaper of general circulation within the Municipality a notice in the form of Exhibit "C" attached hereto.

<u>Section 4</u>: Registration Rules and Forms. The registration rules for the Registry have been previously approved by the Corporate Authorities of the Municipality as Ordinance 3235-2000 and are available from the Village Clerk.

Section 5: Joint Review Board to be Convened. A joint review board as set forth in the TIF Act is hereby convened and such board shall meet, review such documents and issue such report as set forth in the TIF Act. The first meeting of said joint review board shall be held at 9:00 a.m. on the 28th day of November, 2018, at the Frank Alexa Training Room, Hoffman Estates Village Hall, 1900 Hassell Road, Hoffman Estates, Illinois 60169. The Municipality hereby expressly finds and determines that said date is at least 14 days but not more than 28 days after the notice to affected taxing districts hereinafter authorized in Section 8 of this ordinance will be mailed.

Section 6: Time and Place of Public Hearing Fixed. A public hearing (the "Hearing") shall be held by the President and Board of Trustees of the Municipality at 6:50 p.m. on the 7<sup>th</sup> day of January, 2019, in the Helen Wozniak Council Chambers, Hoffman Estates Village Hall, 1900 Hassell Road, Hoffman Estates, Illinois 60169, for the purpose of hearing from any interested persons or affected taxing districts regarding the proposed designation and approval of the Redevelopment Plan and Project.

Section 7: Publication of Notice of Hearing. Notice of the Hearing, substantially in the form attached hereto as Exhibit "B", shall be published at least twice, the first publication to be not more than 30 nor less than 10 days prior to the Hearing, in a newspaper of general circulation within the taxing districts having property in the Redevelopment Project Area.

Section 8: Mailing of Notice of Hearing Authorized. (a) Notice shall be mailed by certified mail not less than 10 days prior to the date set for the Hearing, addressed to the person or persons in whose name the general taxes for the last preceding year were paid on each lot, block, tract or parcel of land lying within the proposed Redevelopment Project Area. In the event taxes for the last preceding year were not paid, the notice shall also be sent to the persons last listed on the tax rolls within the preceding three years as the owners of such property. Notice shall also be given within a reasonable time after the adoption of this ordinance by first class mail in the form attached as Exhibit "C" hereof to all residential addresses located outside the proposed Redevelopment Project Area and within 750 feet of the boundaries of the proposed Redevelopment Project Area and to those organizations and residents that have registered with the Municipality for that information in accordance with the registration guidelines herein established by the Municipality. Notice shall also be given by certified mail to all taxing districts of which taxable property is included in the proposed Redevelopment Project Area and to the Illinois Department of Commerce and Economic Opportunity not less than 45 days prior to the Hearing, and such notice (i) shall advise the taxing bodies represented on the joint review board of the time and place of the first meeting of the joint review board and (ii) shall also include an invitation to each taxing district and the Illinois Department of Commerce and Economic Opportunity to submit written comments prior to the date of the Hearing to the Village, to the attention of the Village Clerk, Village Hall, 1900 Hassell Road, Hoffman Estates, Illinois 60169 concerning the subject matter of the Hearing. Each such mailed notice to the taxing districts shall include the name of an appropriate person to contact for additional information, and a copy of the proposed Redevelopment Plan, including the Eligibility Study contained therein.

<u>Section 9</u>: Superseder; Effective Date. All ordinances, resolutions, motions or orders in conflict with the provisions of the Ordinance are, to the extent of such conflict, hereby repealed. This Ordinance shall become effective upon its adoption.


THAT PART OF SECTION 36, TOWNSHIP 42 NORTH, RANGE 9 EAST OF THE THIRD PRINCIPAL MERIDIAN AND ALSO PART OF FRACTIONAL SECTIONS 5 AND 6, TOWNSHIP 41 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL MERIDIAN BOUNDED AND DESCRIBED AS FOLLOWS:
