#### 3. CHAIRMAN'S REPORT

Chairperson Combs stated that the preliminary and final site plan and preliminary and final plat of subdivision, preliminary and final site plan (Phase 1) and plat of dedication, and Master Sign Plan Amendment dated 9/5/18 for the Huntington 90 property were approved by the Village Board.

5. NEW BUSINESS - PUBLIC HEARING - REQUEST BY JOHN REBMANN (OWNER) FOR A VARIATION FROM SECTION 9-3-6-K-1 TO ALLOW FOR A GARAGE THAT IS APPROXIMATELY 206 SQUARE FEET, VERSUS THE MINIMUM 440 SQUARE FEET REQUIRED, AT THE PROPERTY LOCATED AT 645 MORTION STREET.

John Rebmann presented an overview of the project.

Mo Khan presented an overview of the staff report.

Commissioner Trieb asked about the tampering with his motorcycles. Mr. Rebmann stated someone knocked over his motorcycle, which has happened 2-3 times over the 10 years he has lived there.

Commissioner Harner asked if the petitioner has considered building a garage in the back of the home, like other neighbors in the area. Mr. Rebmann stated because of the expense and the backyard is not evenly graded which causes flooding, this would not be feasible.

Vice Chairman Caramelli asked what type of enclosure will be used to surround the existing garage. Mr. Rebmann stated a frame studded wall and a garage door for the one side.

Chairperson Combs said it is her understanding that the petitioner has already done this work. Mr. Rebmann stated yes. All he did was build a partition wall and no structure was changed, and he assumed no permit was needed. Mr. Rebmann stated if approved, staff stated he will need to get a permit, and stated he has no problem with that.
