### 6.E. Treasurer's Report

Mrs. Musiala stated that during the month of February 2018, for Operating funds cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$860.311, primarily due to the start of property tax revenue being received. After including these receipts and disbursements, the balance of cash and investments for the operating funds is \$38.9 million.

For the Operating, Debt Service and Capital Projects funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$1.73 million, primarily due to property tax receipts.

For the Trust Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$11.5 million, primarily due to investment activity in the Pension funds and property tax receipts.

The total for cash and investments for all funds increased to \$224 million.
