# 7. PLANNING & ZONING COMMISSION:

- **7.A.** Approval of a request by Hoffman Village Station LLC (owner) and Sevan Engineering (applicant) to consider the following requests for the Hoffman Village Shopping Center located at 2575 W. Golf Road: 1) special use per Section 9-8-2-C-1 of the Zoning Ordinance to allow an automobile service station; 2) preliminary and final site plan approval for a Mariano's Service Station; and 3) amendment to the Master Sign Plan for the Hoffman Village Shopping Center located for the Hoffman Village Shopping Center, located at 2575 W. Golf Road, subject to the following conditions:
- 1. The development shall substantially conform to the plans presented as part of this application except as such plan may be changed to conform to Village Codes and Ordinances and the following conditions.
- 2. No outside storage display or sales area is permitted with this approval. Any future changes to the outdoor sales area is subject to site plan approval.
- 3. As required by Village Code, a letter of credit to secure site improvements shall be submitted prior to issuance of a building permit.
- 4. Except as specifically amended as part of this request, all provisions of the Master Sign Plan for the Hoffman Village Shopping Center dated March 8, 2011 shall remain in effect.
- 5. A minimum of five (5) additional planter boxes shall be installed to delineate the sidewalk extension along the frontage of the shopping center. The placement of these planters shall be in a manner acceptable to the Village Engineer.
- 6. The fueling station shall only be operable during grocery store hours and an attendant must be present during operation.

# **Discussion**

Tim Kratz, Dan Farrell and Bob Myers all representing Mariano's were present.

Mr. Kratz talked about their updated plans.

Mr. Farrell expanded on their plans.

Trustee Newell asked if they were going to have charging stations. Mr. Farrell replied no.

Trustee Mills asked if they accepted all of the conditions. Mr. Farrell replied yes.

Trustee Arnet asked how many stations would they have. Mr. Farrell replied ten pumps.

Trustee Mills asked if they had concerns with trucks being able to maneuver around the site. Mr. Farrell said no.

She asked if staff had any concerns on traffic at the site. Mr. Gugliotta said no.

Mr. Myers spoke highly of the Kroger fuel program and said that he thinks that Mariano's may move if the fuel program isn't allowed.

Trustee Stanton asked if they believe that customers who would have parked in the 89 lost parking spots will now park in the spots to the east. Mr. Myers and Mr. Kratz responded yes.

Marish Patel, Subway owner, feels that parking would be a problem for the stores to the west of the shopping center.

Akhtan Ramzanali, Dunkin' Donuts owner also said that parking is already a problem because of too few spaces, cars backing up to get out of the center and cars traveling to the south exit endangering the customers visiting those spots.

Rick Heidner, 20 Brinker Rd., Barrington Hills, presented pictures showing the parking lot, the lack of parking and stated that there is no need for another fuel station.

Trustee Pilafas asked about the Mariano's employees currently parking in the spots near the Dunkin' and Subway stores. Mr. Myers said that he would look into it but that he didn't think that it was a problem.

Trustee Stanton asked if they would mark certain spots for certain parking only. Mr. Myers replied no.

Rick Mistretta, Prairie State Energy, said that he believes delivery will be a problem, the turns are too tight, trucks will have to occupy the other lanes of traffic.

Trustee Gaeta asked when fuel will be delivered. Mr. Mistretta said that fuel is usually delivered when the product is available, drivers are available and the price is right.

Mr. Myers said that they expect to get 1-2 deliveries per day and he feels that they will be able to control when it is delivered.

Commissioner Combs said that the Village doesn't have any restrictions on the size of truck or the time of delivery.

Trustee Stanton asked if the size of the truck was talked about at the hearing. Mr. Gugliotta said that it was review and that trucks use oncoming lanes at all fuel stations.

Trustee Mills asked if they would accept another condition if this became a problem. Mr. Farrell replied yes.
