Purpose: Discussion regarding 2021 block parties.

Background: Due to the COVID-19 pandemic and the state restrictions on gathering sizes, the Village Board opted not to process permits

for resident block parties during the 2020 season. Staff has begun receiving inquiries for the 2021 season and is requesting guidance from the Committee/Village Board on how to proceed.

As COVID-19 metrics continue to improve, all areas of Illinois remain in the "Bridge Phase," enacted May 14, 2021. The Bridge Phase allows outdoor social events of up to 500 attendees. Based on updated guidance from the U.S. Centers for Disease Control (CDC), the state revised its mask guidance in May to allow vaccinated adults to gather with those outside of their households without masks. It is anticipated that Illinois will move into Phase 5 of the Restore Illinois Plan as soon as June 11, 2021; as currently presented, Phase 5 would eliminate all

gathering size restrictions.

Discussion: Staff conducted a brief survey of surrounding communities

regarding their current block party policies (see attached). Of those that responded, all are allowing block parties in 2021, provided that the event aligns with any state guidance in place at the time it is held. Other than Palatine, the communities that normally provide a Police and/or Fire presence (as Hoffman

Estates typically offers) have resumed this practice.

Based on changing federal and state guidance and the results of the area survey, staff recommends that the Village resume

permitting for resident block parties for the 2021 season.

Financial Impact: None.

Recommendation: Discussion purposes and to direct staff as to whether block party

permits should be processed for the 2021 season.
