




CONDITIONS OF PERMIT ISSUANCE

EXTERIOR COVERINGS
SIDING, BRICK & VENEERS

A permit for the above-referenced project is hereby approved subject to the following conditions:

1.	<p>Every occupied structure in the Village of Hoffman Estates has upon it an outside water meter reading device. Please be advised that the applicant is responsible for the removal, reinstallation, and any damage that may occur to the outside reading device during any building modification work. Please note that one of the devices depicted below is situated on your building.</p> <div style="display: flex; justify-content: space-around; align-items: center;">    </div> <p style="text-align: center; font-weight: bold;">DO NOT DISCONNECT WIRING TO THE REMOTE METER READER DEVICE. SIDING MUST BE SLOTTED OR JOINTED AT DEVICE TO AVOID CUTTING OR REMOVING WIRING. FAILURE TO DO SO MAY RESULT IN A SERVICE CHARGE FOR THE VILLAGE TO REINSTALL.</p>
2.	The exterior wall envelope shall be designed and constructed in a manner that prevents the accumulation of water within the wall assembly by use of an approved water-resistive barrier installed per manufacturer's specifications.
3.	Wall coverings, backing materials and their attachments shall be capable of resisting imposed wind loads.
4.	Siding shall be certified and labeled as conforming to ASTM D 3679.
5.	Siding and veneers shall be installed per manufacturer's instructions.
6.	Stone or masonry shall be supported on a brick ledge or by a steel angle designed by an Illinois licensed architect or structural engineer.
7.	A FINAL INSPECTION IS REQUIRED UPON COMPLETION. CALL CODE ENFORCEMENT AT 847-781-2631 TO SCHEDULE INSPECTION APPOINTMENTS. INSPECTIONS ARE ON A FIRST-COME FIRST-SERVED BASIS (NO SAME-DAY INSPECTIONS WILL BE SCHEDULED).

The undersigned also acknowledges the following:

- The Village's Refuse Franchise Program with Groot Industries requires all permanent and temporary roll-off dumpsters must be provided by Groot. To purchase a dumpster contact 1-800-244-1977 or visit www.groot.com.
- There may be private covenants, conditions or restrictions on the property which control the improvements that may be made on the property. The owner is responsible to contact any Owner's Association (HOA, POA, etc.) prior to commencing work to ensure compliance with any private covenants.
- The Village, by issuance of a building permit has no power to and does not abrogate, vary, terminate, waive, or release any such covenants, conditions, and restrictions of record which may be applicable to the subject property.
- The Village of Hoffman Estates, its officials, agents and employees will not enforce private covenants nor directly supervise the performance of any work by a contractor as a consequence of the issuance of this permit.
