Mrs. Musiala stated that during the month of October 2021, for Operating funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$4.6 million, primarily due to receipt of property taxes. After including these receipts and disbursements, the balance of cash and investments for the operating funds is \$63.7 million.

For the Operating, Debt Service and Capital Projects funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$9.8 million, primarily due to receipt of the property taxes and the transfer of the SVO Grant.

For the Trust Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$230,237, primarily due to the receipt of property taxes.

The total for cash and investments for all funds increased to \$304 million.
