- 3. Animals on site shall be supervised at all times by business staff.

- 4. The exterior shopping center areas in the front, near the pet relief area, and in the rear shall be maintained in a clean and orderly manner.
- 5. No grooming, long-term kenneling, boarding, daycare or overnight stays will occur at this facility.

Mike Pierce, 6 Wood Oaks Drive, Barrington, was present to answer any questions.

There was a lengthy discussion on the area where pets could relieve themselves, who would and how often it would be cleaned up.

Trustee Mills asked if there would be overnight stays, Dr. Pierce stated that if they did have a pet who needed to stay overnight they would be transported to another clinic.

Trustee Newell asked if the Goodwill drop-off area would interfere with pet relief area, Commissioner Combs replied no.
