- **7.A.** Request Board concurrence with the Planning and Zoning Commission recommendation and Board approval of Ordinance No. 4949-2022 granting a variation for the property located at 1990 Chippendale Road. Subject to the following conditions:
- 1. The building permit shall be obtained within twelve (12) months of the Village Board action on this request.
- 2. The fence shall significantly conform to the attached plans except as such plans may be changed to conform to Village Codes and Ordinances.

- **7.B.** Request Board concurrence with the Planning and Zoning Commission recommendation and Board approval of Ordinance No.4950-2022 granting a preliminary and final site plan, including a plat of easement, for the property located at 2280 W. Higgins Road. Subject to the following conditions:
- 1. The building permit shall be obtained within twelve (12) months of the Village Board action on this request.
- 2. The following Subdivision Code landscaping waivers are granted:
- a. A waiver from Section 10-4-4-B.a allowing the following landscaping setbacks:
- 1. A side yard landscape setback of 4.5' versus the required 10' for the east side of the site.
- 2. A side yard landscape setback of 4.5' versus the required 10' for the west side of the site.
- 3. A performance guarantee based on an Engineers Estimate of Cost shall be submitted to the Village prior to issuance of a building permit.
- 4. The petitioner acknowledges that an impact fee will be due in accordance with the Village's Road Improvement Impact Fee Program. Based on the projected building use, the Village's Road Improvement Impact Fee is determined to be \$46,212.56. The fee must be submitted prior to issuance of any Certificate of Occupancy for this development. The Developer has the option of entering a Post-Occupancy Monitoring Study Agreement in lieu of submitting the fee prior to issuance of any Certificate of Occupancy. A letter of credit in the amount of \$50,000 would be required should the Developer choose to do a Post-Occupancy Monitoring Study.
- 5. A permit from IDOT shall be submitted prior to construction commencing in the Higgins Road right-of-way.

- 6. A permit from the Metropolitan Water Reclamation District (MWRD) shall be provided prior to site construction commencing.
- 7. The following conditions relate to the site construction:
- a. A pre-construction meeting shall be conducted with the Village staff prior to construction commencing.
- b. Fire Department and emergency access to the property shall be maintained at all times. Petitioner shall make any adjustments on the site as needed for access as per direction by the Village.
- c. In accordance with Village Code, construction hours shall be limited to 7 a.m. to 7 p.m. Monday through Friday, and 8 a.m. to 6 p.m. Saturday and Sunday.

#### **Discussion**

Trustee Mills asked if there would be seating inside. Jeanne Roberts, MRV Architects, replied that there would be 54 seats inside the restaurant.

### **6.E.** Treasurer's Report

Ms. Musiala stated that during the month of May 2022, for Operating Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$5.7 million, primarily due to the receipt of water & sewer improvement fees for the Microsoft Data Center project and receipt of Income taxes. After including these receipts and disbursements, the balance of cash and investments for the Operating Funds is \$70 million.

For the Operating, Debt Service and Capital Projects Funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$4.5 million, primarily due to the receipt of the Water & sewer improvement fees for the Microsoft Data Center project.

For the Trust Funds, cash disbursements and transfers-out exceeded cash receipts and transfers-in by \$11.7 million, primarily due to pension fund investment activity.

The total for cash and investments for all funds decreased to \$287 million.
