### A. Community Safety Discussion

Chief Cawley gave a presentation that talked about the recent criminal activity that has taken place on the north side of town. She talked about the police efforts that are happening to detour the crimes and the practices they use to solve them.

Officer Park talked about what residents can do themselves to keep them safer, calling 911, starting a Neighborhood Watch group and the Tip Line.

Sergeant Wondolkowski talked about speeding complaints, tracking the data with counts, time and the speed to have the best time for an officer to watch an area.

Lieutenant Lawrence talked about defending yourself, the rights that you have if someone enters your home and other rights that you have to protect your property.

Chief Cawley talked about new initiatives that will be put into place including a transparency plan on the Village website which will have crime statistics and alerts on it. She also talked about community engagement such as Neighborhood Watch programs and Beat Meetings.

The floor was then opened up for residents to ask questions, those topics included the location of your driver's license when you're driving, speeding in some areas, the use of Ring doorbells, license plate readers, the traffic on Westbury during school drop-offs and pick-ups, dark streets, the difference in the illumination of the street lights, pursuing vehicles, police staffing, solicitors, property rights, cameras to monitor areas, the Safe T Act, speed bumps and drag racing.
