- 1. The Special Use shall be granted solely to Casey's Retail Company and is not transferable.
- 2. The operations shall comply with all restrictions of the Zoning Code Section 9-8-1-C-1.
- 3. If site plan approval for redevelopment of the property is not obtained by September 30, 2023, the Village shall reserve the right to require the site to be brought into substantial compliance with current Village Code requirements. Upon written notification by the Village of the foregoing requirement, the owner shall have one year to develop a site plan in accordance with the current Village Code standards. Upon approval by the Village of the site plan, the plan shall be implemented through the construction of site improvements within one year of the site plan approval.

- 1. The Special Use shall be granted solely to Casey's Retail Company and is not transferable.
- 2. The operations shall comply with all restrictions of the Zoning Code Section 9-8-1-C-1.
- 3. If site plan approval for redevelopment of the property is not obtained by September 30, 2023, the Village shall reserve the right to require the site to be brought into substantial compliance with current Village Code requirements. Upon written notification by the Village of the foregoing requirement, the owner shall have one year to develop a site plan in accordance with the current Village Code standards. Upon approval by the Village of the site plan, the plan shall be implemented through the construction of site improvements within one year of the site plan approval.
- 4. The Petitioner shall enter into a Compliance Agreement with the Village to ensure the convenience store structure is brought into compliance with the Village's fire-suppression requirements. Failure by the Petitioner to enter into said Compliance Agreement by November 1, 2022 shall result in action by the Village, which may include revocation of the Special Use granted with this request.

Request Board concurrence with the Planning and Zoning Commission recommendation and Board approval of Ordinance No. 4968-2022 granting a special use and preliminary and final site plan for Belle Tire, including a variation from Section 9-3-8-L to allow a 60' flagpole and a 20' x 30' American flag located at 4801 Hoffman Boulevard.

Subject to the following conditions:

- 1. The approval of the Special Use shall be based on the application materials submitted by the petitioner for this request.
- 2. The building permit shall be obtained within twelve (12) months of the Village Board action on this request.
- 3. The following Subdivision Code landscaping waiver is granted:
- 4. A waiver from Section 10-4-4D.a. to not provide foundation landscaping on the north, west and south building façades.
- 5. A variance from Section 9-3-8-L of the Municipal Code is granted to allow a 60' flag pole and a 20' x 30' American flag.
- 6. A building permit is required for flagpole installation.
- 7. Signs are not approved through the site plan process and require separate permit submittal for review.
- 8. A performance guarantee based on an Engineers Estimate of Cost shall be submitted to the Village prior to issuance of a building permit.
- 9. The petitioner acknowledges that an impact fee will be due in accordance with the Village's Road Improvement Impact Fee Program. Based on the projected building use, the Village's Road Improvement Impact Fee is determined to be \$29,162.81. The fee must be submitted prior to issuance of any Certificate of Occupancy for the development. The Developer has the option of entering a Post-Occupancy Monitoring Study Agreement in lieu of submitting the fee prior to the issuance of any Certificate of Occupancy. A letter of credit in the amount of \$30,000 would be required should the developer choose to do a Post-Occupancy Monitoring Study.
- 10. A permit from the Metropolitan Water Reclamation District (MWRD) shall be provided prior to site construction commencing.
- 11. Outside storage is not permitted except as provided in Section 9-8-5-E of the Zoning Code.
- 12. The following conditions relate to the site construction:
- a. A pre-construction meeting shall be conducted with the Village Staff prior to construction commencing.
- b. Fire Department and Emergency Access to the property shall be maintained at all times. Petitioner shall make any adjustments on the site as needed for access as per direction by the Village.
- c. In accordance with Village Code, construction hours shall be limited to 7 a.m. to 7 p.m. Monday through Friday, and 8 a.m. to 6 p.m. Saturday and Sunday.
