PURPOSE:

Request authorization to go out to bid in four batches of Village accounts for an electricity contract starting December 2023, select a supplier based on the recommendation of Satori Energy and adopt an ordinance establishing an electricity purchasing process allowing the Village Manager to enter into resulting contracts with a third party supplier for the Village pumping, street lighting and NOW Arena electricity accounts.

BACKGROUND

In January, 2007, ComEd eliminated subsidized fixed-rate electricity service for non-franchise municipal accounts. To bring a cost-effective electricity supply alternative to municipalities in northern Illinois, the Metropolitan Mayors Caucus and Satori Energy (formerly Energy Choices) joined forces to create the Metropolitan Energy Collaborative (the "Collaborative"). The Collaborative sought supply from a multitude of pre-qualified suppliers to secure lower-priced electricity to municipalities. In the first year, the Collaborative saved municipalities an average of 27% on their electricity supply charges over ComEd's unsubsidized bundled fixed rate. The Collaborative continues providing cost-effective electricity supply to municipalities for pumping and street lighting accounts, as well as residential accounts for 32 municipalities in northern Illinois.

Although record low energy prices and cost savings for the Village are not part of the current market, the Village does still see a tremendous benefit in utilizing the services of Satori Energy for their expertise and guidance in the electricity market.

DISCUSSION

All Village electricity accounts are currently under contract with Constellation Energy and are up for renewal in December, 2023. Pricing under this current contract is \$0.04856/kWh for the pumping sites and \$0.02699/kWh for street lighting. This has been the lowest rate the Village ever paid and was entered into by the Village back in December, 2020 when prices were extremely low. Unfortunately, energy markets have increased substantially since then. Electric prices are up over 100% since the start of 2022. This coming winter could further destabilize the market, especially of it is colder than average.

Current pricing supplied by Satori Energy is around \$0.07/kWh which will result in about a \$30,000 increase in annual Village electric expense. The

NOW Arena, which has a much higher usage, will see about a \$45,000 increase in annual electric expense. This pricing includes a considerable discount for locking in pricing at least 12 months prior to the contract's commencement.

Due to the current high pricing and the uncertainty of the electricity market, the Village's representative from Satori Energy is recommending that we separate all of the Village's electrical accounts into four batches and lock in pricing now for just one of the batches (1/4th of the Village's usage). We then would look at current pricing every three months and lock in another batch of accounts. This would allow us to spread out the pricing risk and potentially be able to realize savings if pricing falls in the near future. If at any point the market falls, the balance of the accounts may be locked into the favorable rates at once.

Because of the timing of the electricity bidding process, bids must be received on the day that contracts are signed. Staff is looking for authority from the Village Board to go out to bid for an electricity supplier in four batches over the next year, select a supplier based on the recommendation of Satori Energy and allow the Village Manager to enter into a contract with the third party supplier at or below a certain rate listed below. Corporation Counsel has drafted an ordinance to give the Village Manager that authority for 2023 and 2024.

A price comparison is attached of current pricing. This pricing changes daily. We are looking to execute a 1 year contract for the NOW Arena and a 2 or 3 year contract for the Village's pumping and street lighting accounts, in four batches. We are requesting permission to sign a new contract at or below \$0.075/kWh for pumping accounts and the NOW Arena and at or below \$0.055/kWh for street lighting accounts.

RECOMMENDATION:

Request authorization to go out to bid in four batches of Village accounts for an electricity contract starting December 2023, select a supplier based on the recommendation of Satori Energy and adopt an ordinance establishing an electricity purchasing process allowing the Village Manager to enter into resulting contracts with a third party supplier for the Village pumping, street lighting and NOW Arena electricity accounts.

Electric Supply Pricing Proposal







ORDINANCE NO. - 2023

VILLAGE OF HOFFMAN ESTATES

AN ORDINANCE AUTHORIZING TO GO OUT TO BID IN FOUR BATCHES OF VILLAGE ACCOUNTS FOR AN ELECTRICITY CONTRACT STARTING DECEMBER 2023, SELECT A SUPPLIER BASED ON THE RECOMMENDATION OF SATORI ENERGY, AND ADOPT AN ORDINANCE ESTABLISHING AN ELECTRICITY PURCHASING PROCESS ALLOWING THE VILLAGE MANAGER TO ENTER INTO RESULTING CONTRACTS WITH A THIRD PARTY SUPPLIER FOR THE VILLAGE PUMPING, STREET LIGHTING AND NOW ARENA ELECTRICITY ACCOUNTS

WHEREAS, in 2007 the Village joined in a collaborative electricity purchasing process with the Metropolitan Mayors Caucus and electricity consultant, Satori Energy in response to the elimination of subsidized fixed-rate electricity service for non-franchise municipal accounts; and

WHEREAS, utilizing the electricity purchasing process provided through the Collaborative has resulted in significant electricity savings over the unsubsidized ComEd rate for the Village; and

WHEREAS, the current Village electricity accounts for pumping, street lighting, and the NOW Arena are under contract with Constellation Energy and set to expire in December 2023; and

WHEREAS, the Village anticipates an increase in electricity prices due to market conditions, and believes it to be in the best interest of the Village to continue utilizing the services of the Collaborative's consultant, Satori Energy, for their expertise and guidance in navigating the electricity market; and

WHEREAS, Satori Energy has advised the Village that bidding and executing electricity purchase agreements for the Village accounts in batches and at different times will help the Village recognize the greatest electricity cost savings; and

WHEREAS, volatility in the electricity purchasing market requires the ability to bid and lock-in prices within a short amount of time.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

<u>Section 1</u>: The Village Manager shall have the authority to engage in the electricity purchase bidding process for the Village electricity accounts with contracts expiring in December 2023, and that upon the advice of the Village's electricity purchasing consultant, the Village Manager may bid the Village accounts in batches and at different times.

Section 2: The Village Manager shall have the authority to execute electricity purchase contracts for the Village electricity accounts with contracts expiring in December 2023, provided that the contract rates do not exceed \$0.075/kWh for the pumping and NOW Arena accounts and \$0.055/kWh for the street lighting account.

<u>Section 3</u>: This electricity purchasing policy shall remain in effect for fiscal years 2023 and 2024 and may be amended, terminated, or extended by Ordinance.

<u>Section 4</u>: The Village Clerk is hereby authorized to publish this Ordinance in pamphlet form.

<u>Section 5</u>: This Ordinance shall be in full force and effect immediately from and after its passage and approval.
