This new development along the east side of the Bell Works campus, east of Barrington Road and north of I-90, will include 164 townhouse units. In addition to the townhomes, a 300-unit luxury apartment development has also been proposed for the 150-acre Bell Works site.

Initiatives to transform the former AT&T campus into a "Metroburb" with a mix of commercial, professional, and residential spaces have been ongoing since 2019 when the property was purchased by Inspired by Somerset Development. The main commercial building on the campus continues to attract new businesses to Hoffman Estates, with office and co-working space, a conference center, fitness center, eateries, and event spaces.

Several new tenants recently held grand opening celebrations at Bell Works, including Heritage Crystal Clean, an environmental services firm that relocated its 140-employee headquarters to Hoffman Estates from Elgin. Other new business tenants include Headline Solar, Berkshire Hathaway/ Starck Real Estate, Mortgage Mac, and Club Colors screen printing, which will bring 150 employees to Bell Works.

An additional 15,000 square feet of "Ready-to-Wear" office space is expected to be leased out in the facility this year to accommodate more small businesses and professionals.

Village seeks **feedback** for future **retail and restaurant** recruitment

Historian's notebook

With recent food and shopping additions in Hoffman Estates like Crumbl Cookies and HomeGoods, the Village's Economic Development Commission is seeking feedback from residents about what other types of retail businesses and restaurants they would like to see open in Hoffman Estates.

In a dark corner of a storage warehouse sits a box of dusty files. One of the files is the cold case file of the Teets family murders over 43 years ago. Husband Earl, wife Elizabeth, son Gary and their dog were all killed in their farmhouse on Shoe Factory Rd. in Hoffman Estates on January 11, 1979. To this day the murders remain unsolved.

The Cook County Sheriff's Police were called to the scene after another son, Earl Jr., discovered their bodies. A neighbor had gone to visit them and called Earl Jr. when they got no response to their repeated knocking and horn blowing.

The Teets family lived a quiet farming life. Earl Sr. was a heavy equipment operator, and his son Earl Jr. was the farmer in the family, raising Black Angus cattle and growing corn and pumpkins. A portion of the farm was a pound for abandoned or damaged cars. They kept guard dogs on the property with warning signs posted on the farm. There was also a service station-style warning bell that rang when a car crossed over the hose stretched across the road at the front gate of the farm. Security was important, yet somehow, the

intruders murdered the family.

There isn't a time that I don't think of them as I travel near the farm. Nothing is left of the homestead now. A fire in early September 1979 took the main farmhouse. Firefighters determined that it was arson – vandals they said. Since it was abandoned property, the fire was left to burn safely to the ground. The Hoffman Estates Fire Department was called to the property once again on October 12, 1979 with the remainder of the buildings - a small barn and two small sheds - ablaze under suspicious circumstances. As with the earlier fire, these were allowed to safely burn out.

I've never taken a walk to the property, now part of the forest preserve, but would like to see where this family lived and what is still there. Their memory haunts me – all that I know is that it will remain a cold case file stored away in some warehouse, only to be taken out if or when some new evidence is brought forward and presented to the Cook County Sheriff's Police.

Online building permit tips

The Village's new online building permit system, eTRAKiT, went live this past January. The Village continues to make updates to the system to provide an excellent user experience.

Here are some great tips for those using the new eTRAKiT portal for the first time:

- Access to the eTRAKiT portal is through the Building Permits webpage at hoffmanestates.org/permits.
- Google Chrome is the best web browser to use while working in the eTRAKiT portal.
- Start by searching address numbers without the street name to broaden the search.
- Check the DASHBOARD to see all active permits. Previously saved information is accessible through the dashboard.
- Online payments for building permits should be made using the eTRAKiT portal. If a
 payment is accidentally made elsewhere on the Village's website, please contact the
 Building Division directly at 847-781-2631 as soon as possible.
- If you receive an error that your account does not exist when trying to log on, verify that you are in the eTRAKIT portal and not the Village's website login page.



- A contractor or public account can be created at any time. If you are anticipating an
 upcoming permit, feel free to create your account ahead of time. This is especially
 useful for contractors who also need to complete the contractor license process.
- As a reminder, contractors follow a different process to create an account and must first contact the Building Division directly.

Electronics Recycling Drop-off Program Resumes in April

Hoffman Estates residents can drop off old, unwanted electronics for recycling at Village Hall, 1900 Hassell Rd., on Mondays between 10 a.m. and noon starting April 3. This electronic recycling program, provided in cooperation with the Solid Waste Agency of Northern Cook County (SWANCC), runs through the end of November. There is no charge to residents for this service, but all recycling must come from households.

The following electronics will be accepted for drop off as part of the program: computers (PCs, laptops and tablets) and computer components (monitors, keyboards, mouse devices, drives, etc.), TVs, VCRs, DVD players, fax machines, MP3 players, printers, scanners, and video game consoles. Visit swancc.org for a full list of accepted items.

Residents from all SWANCC communities are eligible to participate; addresses will be verified. Electronics will not be accepted outside of the posted dates and times. Visit hoffmanestates.org/garbage for additional information about recycling and waste collection.

Get a jump on **spring cleaning** with discounted **roll off containers** from Groot

As part of their contract with the Village, Groot offers Hoffman Estates residents discounts on roll off containers for a set-two-week period once a year. For the 2023 program, 10 cubic yard dumpsters are \$189.02, and 20 cubic yard dumpsters are \$270.79.

The discount period will begin on:

- April 3 for residents in Zone A (All streets north of the Tollway (I-90) and all streets west of route 59)
- April 17 for residents in Zone B (All streets within the boundaries north of Golf Road, south of the Tollway, east of Barrington Road and west of Roselle Road)
- May 1 for residents in Zone C (All streets within the boundaries north of Schaumburg Road, south of Golf Road, east of Barrington Road and west of Roselle Road)
- May 15 for residents in Zone D (All streets within the boundaries north of Schaumburg Road, south of Golf Road, east of Roselle Road and west of Plum Grove Road)

See the zone map on page 5, which is also used for branch pickup.

The discounted dumpsters are for residential use only, and are not to be utilized by contractors. Materials including but not limited to liquid waste, concrete, dirt, roofing shingles, landscape waste, tires, electronic waste, remodeling waste, or white goods will not be accepted in the dumpsters.

Spring branch pick-up begins by zone on **April 24**

The free curbside spring tree branch pickup program through Hoffman Estates Public Works begins on Monday, April 24, starting with Zone A. This program is for residents covered by the Village refuse collection contract.


Please note that only one collection pass will be made for each street with no exceptions. If branches are too large, are mixed with unacceptable materials or have not been prepared properly, they will not be picked up.

Public Works crews WILL accept:

- Tree branches no larger than 8 inches in diameter and/or 10 feet in length
- Shrub trimmings and similar brush
- Branches from willow trees if separated from other materials

Public Works crews will NOT accept:

- Tree trunks, stumps or root balls
- Firewood
- Railroad ties or landscape timbers
- · Grass clippings, leaves, sod, plants or yard waste



BRANCH PICKUP COLLECTION SCHEDULE

ZONE A: Beginning April 24: All streets north of the Tollway (I-90) and all streets west of Route 59.

ZONE B: Beginning May 1: All streets within the boundaries north of Golf Road, south of the Tollway, east of Barrington Road and west of Roselle Road.

ZONE C: Beginning May 8: All streets within the boundaries north of Schaumburg Road, south of Golf Road, east of Barrington Road and west of Roselle Road.

ZONE D: Beginning May 15: All streets within the boundaries north of Schaumburg Road, south of Golf Road, east of Roselle Road and west of Plum Grove Road.

On the first date of pickup listed for your area, neatly stack branches at curbside by 7 a.m., facing the cut ends toward the street. Please do not tie branches in bundles or place in any container. Do not allow branches to protrude into the street or block sidewalks.

While supplies last, free wood chips will be available to residents at the Village's Vehicle Maintenance facility, 2405 Pembroke Avenue, during daylight hours after 3 p.m., Monday through Friday, and during daylight hours on weekends. No-fee garage sale permits required

Residents must obtain a no-fee permit to hold a garage sale. The permit can be acquired by logging onto the Village's eTRAKiT online permitting portal at hoffmanestates.org/ permits. Click the "apply now" link and follow the steps to create a public user account and submit the application right through the portal.

Garage sales are only allowed to take place on Thursdays, Fridays, Saturdays, and Sundays, and a sale may not extend more than four consecutive days. A maximum of three garage sales are allowed per address each calendar year and must take place within the hours of 8 a.m. and 6 p.m. If a garage sale is conducted without a permit, a \$10 "on-site" permit fee will be assessed. Physical symptoms of stress often overlooked

April is National Stress Awareness Month, bringing attention to the negative impact of stress. Stress is the body's reaction to an apparent threat, and can be known as the "fight or flight" response. Many people know that stress can impact mental health, but physical symptoms of stress often get overlooked.

Some of these physical stress-induced effects can include: headaches, upset stomach (diarrhea, constipation, nausea), low energy, insomnia, sweating, shaking, dizziness, rapid heartbeat, and clenched jaw/teeth grinding. Chronic stress may also cause or worsen many existing health problems like



heart disease, high blood pressure, eating disorders, menstrual problems, sexual dysfunction, gastrointestinal problems, or can even cause psoriasis or eczema flare ups.

Not all stress is bad. In fact, life could be boring without any stress at all. Chronic, long-term stress, however, can have harmful impacts on physical and mental health. Cholesterol Screening

This FASTING test measures total cholesterol, HDL, LDL, triglycerides and glucose levels. It requires a small drop of blood. Results are immediate, and include consultation with a nurse. To schedule an appointment, call 847-781-4850. The cost is \$22.

Hemoglobin A1C Screening

The Hemoglobin A1C test is a simple finger stick to find out if you are at risk or have diabetes by measuring your average blood sugar levels over the past three months. The test takes six minutes and the cost is only \$15. Call 847-781-4850 for an appointment.

Children and Baby Clinic

The **Budget in Brief** summarizes the Village's annual budget. To view the entire budget, visit the Village's website at horspace.org/budget.

Each year, the Village of Hoffman Estates establishes an Operating and Capital Budget to guide spending. The operating budget includes funds for services the Village provides to the community, while the capital budget is a long-term plan for larger purchases, such as upgrades to the Village's infrastructure. Together, these documents establish a firm financial foundation for long-term success.


The budget is created over six months, beginning in June. Departments work closely with the Finance Department and the Village Manager's Office to

estimate how much money will be received and spent in the current and upcoming year. After several rounds of review, a draft budget is shared with community stakeholders, including the Village Board and the Capital Improvements Board. Both are comprised of residents who serve to represent the community in budget discussions and decision-making. The Village Board then holds several meetings to review the budget and, if necessary, request changes. At a public hearing, the Board votes to approve and adopt the budget. All budget hearings are open to the public, and community members are invited to participate.

The FY2023 Operating and Capital Budget was approved by the Village Board in early December 2022. The total budget for all funds is **\$167.9 million.**

VILLAGE BOARD STRATEGIC PRIORITIES

The Village Board has established strategic priorities to guide how the Village allocates resources for the community. During the year, the Village strives to communicate these priorities in a clear, direct and proactive manner that increases understanding of the Village's services, initiatives and programs.

REVENUE AT A GLANCE



WHERE DOES THE VILLAGE GET ITS MONEY?

There are several sources of revenue for the Village. The largest is "Charges for Services," like water and sewer charges. "Property Taxes" are the second-largest revenue, followed by "Other Taxes" and "Intergovernmental Revenue." Note that taxes paid to the State of Illinois that are redistributed to the Village, such as income tax, are included under "Intergovernmental Revenue" rather than "Other Taxes." To plan the annual budget, staff conservatively estimate how much money will be received during the fiscal year. In 2023, \$152.8 million in revenue is expected, a 2.8% increase from the 2022 budget. This can be attributed to anticipated increases in sales and income taxes and building permit fees.



REVENUE HIGHLIGHTS

PROPERTY TAXES

Property tax is the Village's secondlargest revenue source. In 2023, there will be no property tax increase for current residents or businesses.

Holding property taxes flat at the previous year level was made possible by positive investment returns in 2021 and strong strategic financial planning.

OTHER TAXES

Other municipal taxes, such as electricity, natural gas, and home rule sales tax, make up **17%** of all revenues.

WATER & SEWER FEES

Water and sewer charges are the most significant portion of all Charges for Services, making up **40.3%** of the \$52.1 million in revenue.





OPERATING TRANSFERS

Nearly **\$5 million** of General Fund reserves will be used toward the \$23.1 million of total capital needs in FY2023. Additionally, approximately **\$2.5 million** in Motor Fuel Taxes received by the Village will be transferred to the Road Improvement Fund for the street revitalization program this year.

PROPERTY TAX DISTRIBUTION

The Village receives only a portion of the property taxes that Hoffman Estates residents and businesses pay. Approximately **85%** of the average property tax bill can be attributed to other taxing districts, such as school, libraries, forest preserves, townships and county government.







SPENDING AT A GLANCE



HOW IS VILLAGE MONEY SPENT?

The Village always makes an effort to anticipate expenses and plan for them within the budget document. Overall, the Village's expenses can be broken down into the categories defined below. Additional detail, such as fund types and how the Village's accounts are structured, can be found in the full budget document. Expenditures in 2023 total \$167.9 million, a 5% increase from the prior year. The increase can largely be attributed to inflation, but is offset by spending less than anticipated on employee benefits for 2023 due to a change in the plan year for the Village's insurance carrier, the Intergovernmental Personnel Benefit Cooperative.

EXPENDITURES BY TYPE FOR ALL FUNDS (IN MILLIONS)



EMPLOYEES

Employees and the services they provide are the Village's most valuable investment. Personnel-related costs make up **46%** of the annual budget.





Commodities include essential goods and everyday items like small tools, office supplies and photocopies. This category only accounts for about **1%** of the Village's budget.



Contractual services most often include expenses related to hiring a third party to complete a service. Examples of a contractual service include insurance, vehicle maintenance and 911 dispatch for police and fire services.




Debt service is the amount of money paid toward principal and interest the Village has incurred from issuing bonds or notes to pay for public projects, like a new building.

GENERAL FUND EXPLAINED

The Village's General Fund receives money and pays for programs and services not otherwise accounted for in a separate fund, which is most of the day-to-day government operations. Examples of spending types across the departments include employee salaries, commodities like salt used to treat roads during winter events, or contractual services with vendors, such as with the Village's insurance provider. Costs related to public safety make up the largest share of the General Fund.

In 2023, General Fund revenues are estimated to be **\$66.8 million**. Expenditures are expected to be approximately **\$71.7 million**, so a transfer of **\$4.85 million** from the fund balance, or savings, is included in the 2023 budget year. This transfer will be used primarily to fund one-time capital projects.

CAPITAL IMPROVEMENTS PROGRAM

The Capital Improvements Program is the Village's multi-year plan for major purchases and improvements to facilities, land, and infrastructure. Capital purchases are considered to be largely one-time costs that are \$25,000 or more, except for vehicles, which are always considered capital projects. With the positive financial results from the two prior years, the Village has made it a priority to tackle its growing list of capital needs in FY2023. This year, \$23.1 million is budgeted for capital purchases. While this represents a 9.1% decrease from 2022, the 2022 budget included items carried over from 2021 that were postponed due to economic uncertainty. The Village will focus on important technology upgrades in 2023, as well as projects in the categories highlighted below.

April Community Workshop: "My Tummy Hurts!"

Often, our bodies can tell us a lot about our emotional health. The Health and Human Services Department is hosting a workshop on Saturday, April 22 from 10 to 11:30 a.m. at Village Hall for parents of school-aged children and adolescents who often have concerns with stomach or abdominal pain, headaches, and/



or fatigue or tiredness. This 90 minute seminar will focus on a child's physical body as a window into their mental health.

This workshop aims to:

- Inform parents how the family as a whole can target stressors to help children manage pain and anxiety.
- Increase parental awareness and understanding of the mind/body connection.
- Allow parents to begin asking questions about their child's emotions as they relate to bodily pain.
- Encourage parents to feel more competent related to their child's health.

Hoffman Estates Police implement use of body-worn cameras



Almost a year ahead of the state mandated requirement date of January 1, 2024, the Hoffman Estates Police Department has already implemented body-worn cameras for all sworn Police Officers and Community Service Officers. The AXON body-worn cameras will record the interactions of the public with officers both audibly and visually.

Illinois Governor JB Pritzker signed House Bill 3653 into law on February 22, 2021, requiring all Police Officers to wear body cameras while on duty or engaged in "any law enforcement-related encounter or activity." The law set deadlines based on the population of the municipality for implementation.

While there are several benefits of the body-worn camera program, the most prevalent is that it increases the public's trust in officers while also providing officer safety. The recording provides better documentation and supports accounts of incidents provided by both the public and officers. AXON cameras are also slated to be installed in all Hoffman Estates Police vehicles this summer.

Studies show that the use of body-worn cameras contributes to better cooperation from the public during police encounters. Because officers are required to advise the public that the interaction is being recorded, some behavior changes toward officers can occur. This change in behavior can help to de-escalate situations, therefore allowing officers to perform their duties without the use of force.

Body-worn cameras also aid in evidence collection. Footage collected at a crime scene can be used in court as documentation of the entire event, and may include details that an officer may have forgotten or inadvertently omitted. Body-worn cameras have been linked to less down time on reports, better corroboration of evidence, and higher prosecution rates.

From a training standpoint, officers are able to use body-worn camera footage to learn from and prepare for specific situations. A previously recorded incident can provide officers with information as to what strategies worked for that incident that could potentially work in a similar incident. This provides an additional professional development opportunity, as the Hoffman Estates Police Department looks for ways to implement better and safer tactics to serve and protect the community.

New cannabis dispensaries opening in Hoffman Estates

A new retail cannabis dispensary recently opened in Hoffman Estates, and another one is expected to open later this spring. Spark'd, at 5 E. Golf Rd. (just east of Roselle Road), held a grand opening celebration and ribbon cutting on January 31, and Exxotic Strains, 1237 N. Barrington Rd. (just south of Golf Rd.), is anticipated to open in March 2023. These are the first two dispensaries that were approved in Hoffman Estates since the Village Board voted to allow adult-use cannabis businesses as a special use in December 2019.

In addition to going through the Village's special use application process, businesses operating as cannabis dispensaries are required to meet numerous State requirements, including those in the Illinois Cannabis Regulation and Tax Act. Both the owners at Spark'd and Exxotic Strains have previous experience working in the cannabis dispensary sector.

The Village Code caps the number of special use permits for the Cannabis Overlay District at three, so there is currently one remaining special use permit available for a future dispensary to open in Hoffman Estates.
