SUBJECT: Update on Transportation Services for Residents

MEETING DATE: April 10, 2023

PURPOSE: Update on transportation services for residents.

BACKGROUND: At the February 13 Transportation & Road Improvement Committee

meeting, the Committee requested an update on transportation services for older residents and residents with disabilities. Services provided by the Village, Townships, and other providers are

summarized below.

DISCUSSION: Village Taxi Discount Program

The Village provides a Taxi Discount Program for residents 60 or older, residents with low income, and/or residents with disabilities. Eligible residents can receive up to 10 coupons per month, with each coupon worth \$7 off a one-way ride beginning or ending in the Village with participating taxi companies. Full program details are available on the Village website at www.hoffmanestates.org/Taxi.

Resident usage of this program has significantly dropped since its peak in 2019. Year-to-date, a total of 181 coupons have been submitted by the participating taxi companies for reimbursement.

Township Transportation Programs

Township Riders Initiative Program (TRIP): Hanover, Palatine, and Schaumburg Township residents 60 or older and 18 or older with a permanent disability are eligible for the TRIP program offering intertownship transportation for medical purposes when crossing township lines. The cost for the service is \$5 each way as a minimum and \$10 each way as a maximum. Pace is the transit carrier and provides a lift-equipped van or small bus. Medical appointments must be located within the boundaries of Barrington, Elk Grove, Hanover, Maine, Palatine, Schaumburg, or Wheeling Townships. Trips to Cook County Hospital or the VA Hospitals in Maywood or Elgin are also eligible.

DISCUSSION (continued):

Residents can find out more information and register by contacting their Township. Residents can find out which Township they live by accessing Township Map at bit.ly/VOHETownship.

Hanover Township: Residents of Hanover Township aged 55 or over, or 18 and over with a permanent disability, are eligible for Dial-A-Bus service within the Hanover Township boundary and five miles beyond. There is a suggested donation of \$1.00 for one-way or \$2.00 for round trip rides. Reservations are required 24-hours in advance and service hours are Monday to Friday from 7:30 am to 3:00 pm.

Palatine Township: Palatine Township residents aged 60 or over, and/or with a disability, are eligible for a curb-to-curb service in a lift-equipped bus at \$2.50 for a one-way trip. Service is available within the Palatine Township boundary, and Arlington Heights and Rolling Meadows for medical appointments on certain days of the week. Additionally, Palatine Township offers a Taxi Discount Program similar to the Village's, although capped at \$4 per trip compared to the Village's \$7 per trip.

Palatine Township provided ridership data for Hoffman Estates residents. As of March 2023, there are 122 Hoffman Estates residents using Palatine Township transportation services. The Township has experienced a similar decline in taxi program users.

Schaumburg Township: Residents of Schaumburg Township aged 55 and over, or 18 and over with a permanent disability, are eligible for \$1 one-way or \$2 round trip door-to-door transportation services on lift-equipped buses. Service is available within the Schaumburg Township boundary, or 7 miles beyond for medical purposes only. Reservations are required 72-hours in advance and service hours are Monday to Friday from 8:30 am to 3:30 pm. All riders must register with the Township prior to service.

Other Transit Options

RTA Seniors Ride Free Program: Village residents 65 or older and meeting certain income requirements are eligible for free transit on fixed routes operated by the CTA, Metra and Pace.

Pace Service: The Village is served by the following Pace routes:

Communication

In addition to gathering the requested information, staff has taken steps to increase awareness of available services including:

- ◆ Updating the "Travel & Transit" page on the Village's website. Previously, the site listed the Townships and then the services available. The new design takes a "services first" approach, highlighting the services and then the township they are available in, all under the headline of "Transportation Services for Seniors & Residents with Disabilities."
- Creating a "Township Map" in GIS to assist residents in finding their township.
- ♦ Inviting township representatives to future Transportation & Road Improvement committee meetings.
- Service-oriented articles in the Citizen newsletter.
- ♦ Working on outreach through Commission for Senior Citizens/Health and Human Services Department.
- ◆ Inclusion of increased connectivity as a goal for the upcoming Multimodal Transportation Plan.

GENERAL UPDATES

- Staff had informal meetings with peers from the Villages of Rolling Meadows and Schaumburg to discuss future opportunities for collaboration.
- Meetings were held with Pace and RTA to discuss the upcoming Multimodal Transportation Plan. The release of the RFP is anticipated in April.
- Pace provided a contact to include in the review process for development proposals. It is anticipated this will be most applicable to future multifamily proposals.
- Staff attended an IDOT webinar on vulnerable road user safety assessments.

TRANSIT UPDATES

Transportation Services

Staff recently coordinated with area Townships and transit organizations to ensure transportation program information was current on the Village's website. Ongoing communication efforts are underway to ensure residents are aware of transportation programs available to older residents and residents with disabilities. A staff update on these efforts will be provided at the April Committee meeting.

Taxi Discount Program

Program registration is ongoing with identification cards and coupons sent to residents. Since its inception, 787 residents have registered for the program, with 331 current eligible registrants. The graph below shows historical, year-to-date use, and an estimate of the 2023 usage. The most recent coupons turned in covered through the end of March.
