## **GENERAL UPDATES**

CMAP made the selection of a consultant team for the Northwest Cook County Transit Coordination Study that will be examining paratransit services throughout the region, including the Hoffman Estates Taxi Discount Program. The team will be led by SRF, a consulting firm with a strong transit and transportation team, and also includes Metro Strategies and Sam Schwartz. The team has considerable regional and national experience in data-driven mobility, transit, and transportation planning. The Village will be participating in a project kickoff meeting at the end of August.

## **Taxi Discount Program**

Program registration is ongoing with identification cards and coupons sent to residents. Since its inception, 801 residents have registered for the program, with 323 current eligible registrants.
