PURPOSE: To present the bids for the 2024 Street Revitalization Project -

Contract #1 and recommend approval of award of contract for this

work.

BACKGROUND: In previous years, the scope of the Street Revitalization Project

included all Village street resurfacing/reconstruction work planned for the year under one contract. As part of the CIP process additional infrastructure improvement needs were identified in the same locations as planned street improvements. To ensure coordination of these improvements while limiting public inconvenience and taking advantage of economies of scale, the scope of the Street Revitalization Project was increased. Due to increased scope, the Street Revitalization Project will be separated into two contracts to ensure competition in bidding and allow for all improvements to be

completed in one construction season.

Street Revitalization Project - Contract #1 includes one reconstruction street, 21 resurfacing streets, and sidewalk improvements on one street. Street Revitalization Project - Contract #2 will include two reconstruction streets and six resurfacing streets. Substantial water, sanitary sewer, and stormwater improvements are also included for most locations in Contract #2. One additional reconstruction street (Batavia Lane) will be included in a separate contract due to DCEO funding. The Batavia Lane project is currently out to bid while Street Revitalization Project - Contract #2 is scheduled to be out to bid in

March.

DISCUSSION: Four bids were received on February 1, 2024. A copy of the proposed

street list and map for Contract #1 are attached. The project scope consists of street reconstruction, resurfacing, curb & gutter, and sidewalk replacement on various streets. The engineer's estimate was

\$3,851,095. A summary of the bids received is shown in Table 1.

The lowest qualified bid was approximately 1.5% below the engineer's estimate. A Lamp Concrete Contractors has worked on several previous street and utility improvement projects for the Village. Previous work was completed in an acceptable manner and A Lamp is listed by IDOT as qualified to perform this type of work.

FINANCIAL IMPACT:

The approved FY2024 budget allocated \$5,740,000 for the Street Revitalization Project and other related street costs from various funding sources. Table 2 below provides a summary of the low bid costs compared to budgeted amounts.

Items in *italics* are estimates. Projects yet to be bid.

While the low bid amount for Street Revitalization Project – Contract #1 is below the total project budgeted amount, the total costs for all Street Revitalization related items are estimated to be \$632,000 over budget at this time. It should be noted that many items have not yet been bid therefore the total amount over/under budget is not yet known. However, it is expected that total costs will remain over budget given the cost increases seen in the Street Revitalization Project - Contract #1 bids.

RECOMMENDATION:

Request authorization to award contract for the 2024 Street Revitalization Project - Contract #1 to A Lamp Concrete Contractors, Inc., of Schaumburg, IL (low bid) in the amount of \$3,787,000.



GENERAL UPDATES

- Staff continues to hold regular meetings and conversations with colleagues in other municipalities and townships to coordinate on transportation issues.

Taxi Discount Program

Program registration is ongoing with identification cards and coupons sent to residents. Since its inception, 816 residents have registered for the program, with 340 current eligible registrants.
