2. PUBLIC COMMENT

3. APPROVAL OF MINUTES – October 3, 2023

5. NEW BUSINESS

a. Build-a-Birdhouse 2024

b. Single-use Plastic Reduction

Co-Chair Lichtenbert reminded Mr. Howe of the infographic that was previously reviewed to be included in a future Citizen or e-News edition. Commissioners Conley and Leisenburg supported future educational efforts focused on plastic-free July.

Commissioner Schwartz proposed holiday packaging recycling information to be included in the e-News near the winter holidays. Commissioner Mulford reminded the group that the due date for the January-February Citizen is November 22nd.

c. Sustainable Practices at Village Events

Mr. Howe provided details on an expanded/altered draft survey prepared using the previous version created by Co-Chair Lichtenbert. This survey will be distributed to commission Chairs once content is finalized.

d. Citizens Utility Board Solar Event
