Approval of Minutes:

New Business:

Chairman Montag stated that Memorial Day would be the same as in the past, and Commissioners should be at the Police Department by 9:30AM. The flag would then be escorted by a Hoffman Estates police officer to St. Peter Lutheran Church in Schaumburg where the ceremony would commence.

4th of July parade will take place on Illinois Blvd., Chairman Montag would notify commissioners as to the staging area for the float as soon as he has been notified for any commissioners who want to walk along side the float.

Other:

Chairman Montag stated he had not received the application yet for the Septemberfest Parade.

Commissioner Kwiatkowski moved to adjourn the meeting at 1:25PM; seconded by Commissioner Mattson.
