




Water Billing

A total of 14,565 residential water bills were mailed in July. Average consumption was 6,842 gallons, resulting in an average residential water bill of \$41.27. Total consumption for all customers for the July billing was 174 million gallons, with 100 million gallons attributable to residential consumption. When compared to the July 2009 billing, residential consumption increased by 25%, which is mostly due to an extra week in the July 2010 billing cycle.

General Fund


For the month of July, General Fund revenues totaled \$2,532,284 and expenditures totaled \$3,595,326 resulting in a deficit of \$1,063,042.




Hotel Tax





State Sales Tax





Geographic Information System Monthly Review

Clerk's Office

Fulfilled thirteen requests for adding or updating location records and re-assigning business licenses in CommunityPLUS.

Code Enforcement

Fulfilled four requests for adding or updating location records and re-assigning permits in CommunityPLUS.

Development Services

Scanned several sheets of the old Police facility plans and forwarded the PDF files to Don Plass. These were to accompany the requests for quotation for demolition of the building at 1200 Gannon Drive. At the same time, I requested that an easement be created along the West edge of the property to allow perpetual access for maintenance of the new fiber optic cable that is buried there.

Created new location records in CommunityPLUS for the addresses at the Heidner Development. The new addresses are 2081, 2085, 2091, and 2095 Barrington Road. The addresses were also added to the Address Label layer in GIS.

Finance

Fulfilled two requests for assistance in identifying the correct location records to be used for two new Fire Alarm Monitoring accounts.

New Police Station

Created new large wall maps for the Front Desk and Emergency Operations Center (EOC) areas at the new Police facility. The Front Desk map was laminated and delivered prior to the move-in date. The EOC map was laminated and delivered during the week following the move-in.

Assisted with logistical and physical support for the move of computers, phones, etc., from the Police facility at 1200 Gannon Drive to the new facility at 411 W Higgins Road.

SPS Monthly Review

FinancePLUS 4.3 Upgrade

Training was held for users of FinancePLUS to go over the new features of the upgraded version. Many of the new options focus on paperless processing for such things as POs, payroll vouchers, as well as the electronic forms-based Workflow Management for new hires, terminations, employee leave requests, although this would require the purchase of additional software to implement. We also continued to test the applications for any problems and to familiarize ourselves with the changes.

CommunityPLUS 8.4 Beta and eGovPLUS 8.4 Upgrade

Planning and testing for these applications continued in July. We also worked on Cognos Report testing with the new catalogs. We are currently planning to go live with all the upgrades at the end of August, if feasible.

Miscellaneous

General Premise License renewal forms were updated and the Renewal process was completed in July.

A permanent fix was installed and tested for a long-standing problem with the Citations Entry Wizard. This fix resulted in much faster data entry times and resolution of errors that were occurring during simultaneous entry.


The Attachments functionality was installed in FinancePLUS so that items can be scanned and attached to check, PO and employee records. This would make possible the electronic storage of all invoices with the AP checks with which they are associated.

Utility Bill Printing


Assisted with the evaluation of bill printing company for the RFP that was sent out this summer. This involved a site visit to the company that was awarded the contract for bill printing and analysis of their capabilities based on their proposal.

eGovPLUS Update

Since its successful launch in June, usage of this software continued to increase in July, albeit at a slower pace than the previous month. The chart below illustrates this point. Prior to July 1st, 975 new accounts had been created and 720 new ones were added between July 1st and 30th.



In comparison, the utilization of the software for UB payments increased during the same period from 940 payments made prior to July 1^{st} , and 1012 for the period July 1^{st} through 30^{th} .



Technical Support Hardware & Software Activities

New Police Facility

Months of planning and preparation culminated in the very successful project of relocating the technology from the old Police facility to its new home at 411 W Higgins Rd. Department personnel spent weeks configuring and pre installing network routers and switches, computers and telephones in an effort to keep downtime on the day of the move to a minimum.


As early as one week prior to the original move date (7/24/2010) the department had established connections with the Village network and were conducting performance testing on the links. These were completed the week of the 17th and the department was ready to meet its commitment for the move on the 24th however, due to issues outside of this department's control, the move date was extended to the 31st. We were able to contact our vendors responsible for assisting us with some aspects of this project (AT&T, Sentinel) and reschedule their services. This was done at no additional cost.

Our portion of the move went relatively smoothly. The first priority was to have the front desk area up and running with as little downtime as possible. To do this 847-882-1818 was forwarded to a location here in the Village Hall and manned by an ASO from the police department. During the relocation of the existing equipment (switches, telephones and computers) from the old location to the new location LEADS/RMS access was down for approximately 2 hours, the time it took to remove, transport and install the existing switches. The front desk was operational within 4 hours of the start of the move.

No telephone service to 847-882-1818 was lost during the move. Once service to the front desk was completed and tested and the ASO brought back from the Village Hall, department personnel completed the installation of existing hardware to the remaining offices and telephones, computers and printers were operational by 5pm that evening.





Toner Usage by Department




