PURPOSE:

To secure fixed rate pricing for natural gas at the Sears Centre Arena and the Village's largest street light account.

BACKGROUND:

Since early summer our Energy Consultant Mollie Vanderlaan at Energy Choices has been tracking natural gas prices at the Sears Centre Arena, as well as the current index rate that we are paying Com Ed for street light electricity, to determine the opportune time to move from a monthly index rate to a fixed rate.

Natural gas is at twelve month lows and our consultant believes it is wise to lock in a fixed note prior to the winter when prices become more volatile. Attached for your review are index prices from July 2009 through September 3, 2010. It is her recommendation that we lock in pricing beginning November 2010 through April 2011. Because we have relatively light usage the remainder of the year there is no benefit to locking in rates beyond April.

Related to electricity, prices have bottomed out and have been for the past year. The Village currently has one street light account that is now "competitive" with Com Ed. This means it is on an hourly index which is highly volatile. Since fixed prices are particularly low, it would be prudent on our part to lock in those rates as well. The recommendation is to lock in a rate through December 2012 which is when our water pumping rates are up for renewal. While it cannot be determined what the savings on power

would be until after the bids are received, the Village stands to save about \$6,000 per year on transmission and distribution costs by moving this account off of Com Ed.

DISCUSSION:

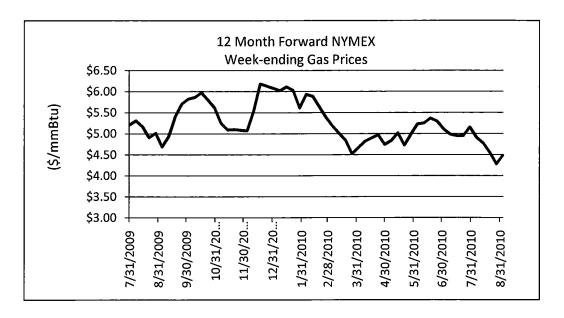
Based on the information above, we would like to go out for bid at the end of the month. As we have done in the past, bids would be compiled by our consultant and a recommendation would be made to the Village. Because prices change daily, we would ask for authorization to allow the Village Manager to accept the most feasible bid and report back to the Village Board with the results.

RECOMMENDATION:

Request authorization to go out for bid on natural gas for the Sears Centre Arena for the period November 2010 – April 2011 and electricity for street lights through December 2012 and request that the Village Manager be allowed to lock in the rate and report back to the Village Board.

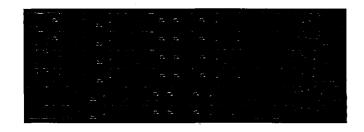

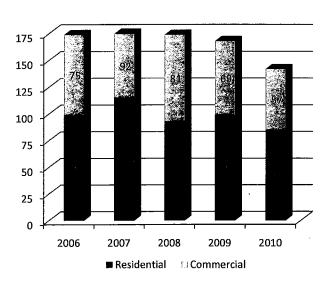
Water Billing

A total of 14,567 residential water bills were mailed on September 1st for July's water consumption. Average consumption was 5,846 gallons, resulting in an average residential water bill of \$35.96. Total consumption for all customers was 142 million gallons, with 85 million gallons attributable to residential consumption. When compared to the September 2009 billing, residential consumption decreased by 14%.

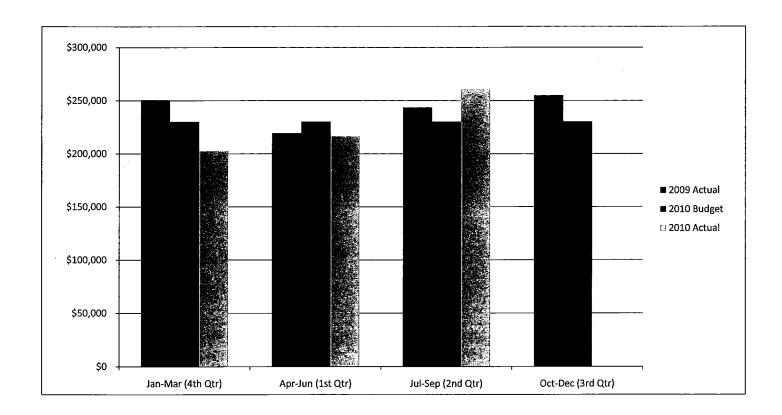
For the month of August, General Fund revenues totaled \$2,435,120 and expenditures totaled \$2,780,903 resulting in a deficit of \$345,783.

Geographic Information System Monthly Review

Clerk's Office

Fulfilled twenty-one requests for adding or updating location records and re-assigning business licenses in CommunityPLUS.

Code Enforcement

Fulfilled two requests for adding or updating location records and reassigning permits in CommunityPLUS.

Information Systems

Received new aerial photograph image files from Northwest Central Dispatch System. The flyover was conducted in the spring of 2010. Analyzed the file set and organized the individual files (323 file groups) that will be used to create the raster dataset in the GIS database.

Through our intergovernmental agreement with the Illinois Department of Transportation, we received a set of their NAVTEQ GIS data files. Started extracting the data for our area and converting it to the local map coordinate system. Currently street, municipality, and county layers have been added to the GIS database. This data expands the range of the map data to the outlying municipalities.

Planning

Crossroads Commons shopping center has been renamed to **India House Plaza** and the GIS database has been updated to reflect this change. The Intranet maps will automatically show the new name, and all paper maps printed going forward will show the change as well.

New Police Station

Created, printed, and laminated five additional large wall maps and three separate inset maps for the Investigations, Traffic Investigations, Tactical, Roll Call, and Detective areas at the new Police facility. These additional maps will save time and make it easier for the various groups to visualize and analyze events and situations.

Miscellaneous

A Staff Geologist with Groundwater & Environmental Services, Inc. in Aurora, Illinois requested Property Index Numbers (PINs) and addresses for all parcels within 800 feet of the parcel at 2 East Higgins Road. The data was extracted from the GIS database and provided, along with a map showing the parcels involved.

SPS Monthly Review

CommunityPLUS 8.4/FinancePLUS 4.3 Go Live

Most of August was spent with the final testing and resolution of problems found in preparation for the upgrade. Many of these items required assistance and coordination with SunGard support and programming staff. Once we were confident that these were resolved sufficiently to proceed with the conversion to the live environment, we planned the upgrade for August 31st. The conversions took most of the day, but were completed as quickly as possible. After brief testing, we turned the applications over to the users. Initially, there were application issues that needed to be resolved, as there are in all upgrades. With the assistance of SunGard, we are able to resolve all the issues as quickly as possible, after prioritizing each.

Utility Bill Printing

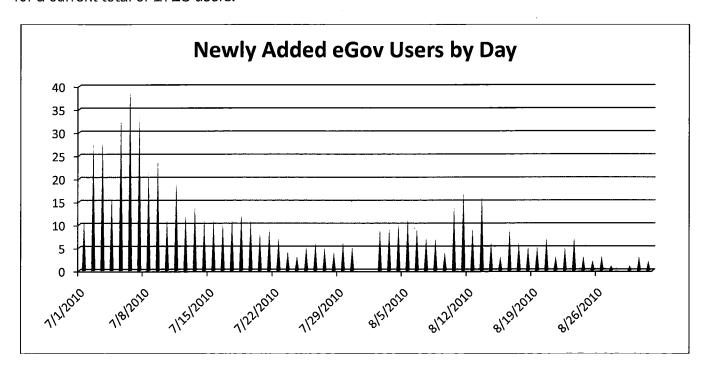
Considerable time was spent this month working with the new vendor chosen to print our Utility Bills each month. We analyzed and redesigned the current layout, which allows us to provide more detailed service information and messaging capabilities of the monthly bills. In the future, we will also be implementing an email form of the bills for those residents who request this option.

Miscellaneous

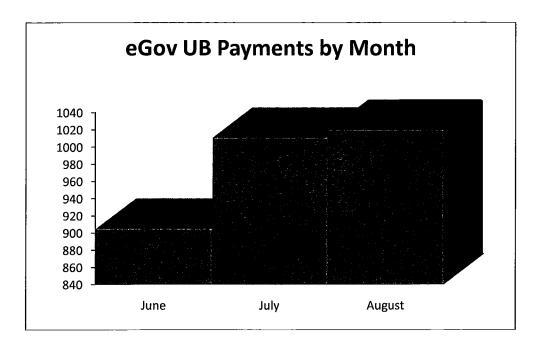

eGov

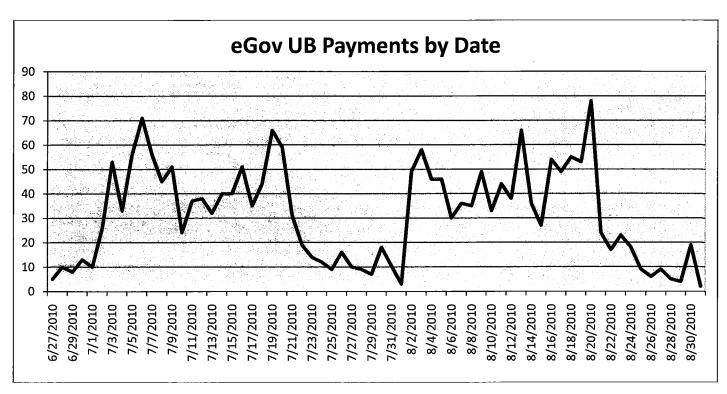
eGov usage continues to increase as evidenced by the addition of 193 new users created in August for a current total of 1728 users.



While the addition rate of new users has leveled off, the number of payments made using eGov has increased every month since inception.



The pattern of when the payments are made each month is consistent from month to month, with the spikes corresponding with the mailing of the bills and then the days leading up to the due date. The low point for each month occurs immediately after the due date has passed.



Technical Support Hardware & Software Activities

User Group Meeting

John Peebles met with the Information Technology User Group and addressed an issue affecting all staff members who received a new PC with the Windows 7 desktop Operating System. He explained that in a Windows Server 2003 network environment those desktop systems running the Windows 7 operating system have issues where print jobs get stuck in the local print spooler resulting in Information Systems staff having to restart the service. He further explained how the print function works in Windows 7 in conjunction with the corresponding network server that manages all the print jobs and that in order to resolve this issue we would be installing and configuring Windows Server 2008r2.

Server Installation

Windows Server 2008r2 was deployed within the network infrastructure. Windows Server 2008 offers IPv6, native wireless, speed and security improvements; improved image-based installation, deployment and recovery; improved diagnostics, monitoring, event logging and reporting tools; new security features such as BitLocker and ASLR; improved Windows Firewall with secure default configuration;

Active Directory roles are expanded with identity, certificate, and rights management services. Active Directory, until Windows Server 2003, allowed network administrators to centrally manage connected computers, to set policies for groups of users, and to centrally deploy new applications to multiple computers. This role of Active Directory is being renamed as Active Directory Domain Services. A number of other additional services are being introduced, including Active Directory Federation Services, Active Directory Lightweight Directory Services, Active Directory Certificate Services (ADCS), and Active Directory Rights Management Services.

Restartable Active Directory allows Active Directory Domain Services to be stopped and restarted from the Management Console or the command-line without rebooting the domain controller. This reduces downtime for offline operations and reduces overall DC servicing.

Policy related improvements

- -All of the Group Policy improvements from Windows Vista are included. Group Policy Management Console is built-in. The Group Policy objects are indexed for search and can be commented on.
- -Policy-based networking with Network Access Protection, improved branch management and enhanced end user collaboration.
- -Granular password settings within a single domain ability to implement different password policies for administrative accounts on a "group" and "user" basis, instead of a single set of password settings to the whole domain.

Disk management and file storage improvements

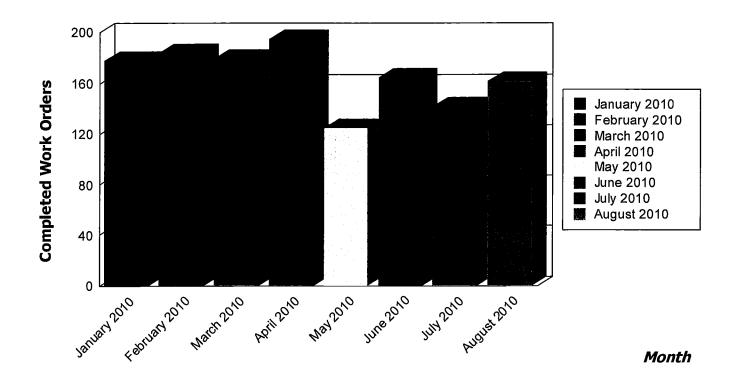
- -The ability to resize hard disk partitions without stopping the server, even the system partition. This applies only to simple and spanned volumes, not to striped volumes.
- -Shadow Copy based block-level backup which supports optical media, network shares and Windows Recovery Environment.
- -DFS enhancements SYSVOL on DFS-R, Read-only Folder Replication Member. There is also support for domain-based DFS namespaces that exceed the previous size recommendation of 5,000 folders with targets in a namespace.
- -Several improvements to Failover Clustering (High-availability clusters).
- -Internet Storage Naming Server enables central registration, deregistration and queries for iSCSI hard drives.

New Police Facility

Information System staff began addressing a number of requests for the new police building.

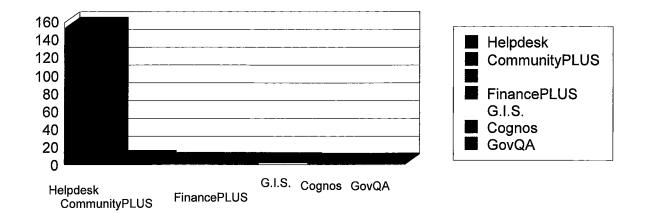
- -I.S. Department staff originally made arrangements for a single Comcast internet connection to be installed within the facility. This line was to take the place of the DSL lines that the detectives and ASO Kravetz utilized at the old facility. We were then informed that vendors involved with the BAS, Lighting and security systems needed access to the internet as well. We reassessed the requests and determined a need for tighter security was needed. As a result we temporarily installing and configuring Cisco PIX device between the Comcast modem and the network switching equipment and VPN credentials for each vendor was established. We have held further discussions with Paul Petrenko with regards to outside access to the various systems and the need for extremely tight security. The Cisco PIX box will be replaced with a Cisco ASA device and all vendors requiring access to the internal systems will need to meet with us to verify how their external system will interact with the internal ones.
- -The EOC equipment was returned from Station 24 giving us a chance to finally install, update, test and if necessary reconfigure the units as needed. All computer systems were subsequently tested and found to be working in both wired and wireless mode. All analog lines and VOIP connection are also working.
- -A need was expressed to extend the network wireless infrastructure beyond the parking garage. The original plans called for a wireless access point to be placed on the exterior of the building thus extending the network into the parking lot and cabling for this access point was run to the chosen location. However, it was decided that there was no need to have the wireless network extended and that all officers would be logging in to the network prior to leaving the garage or could log in at one of the other eight locations throughout the Village if need be. The need that has developed stems from officers wanting to get access to the network while temporarily parked in the parking lot without having to drive into the garage. The I.S. Department was asked to implement wireless access outside the garage but not attach any equipment to the exterior of the building. I.S. Department staff met with a wireless vendor to develop a plan and schedule a site survey to look at possible mounting locations and coverage areas.

Total Work Orders by Priority by Month



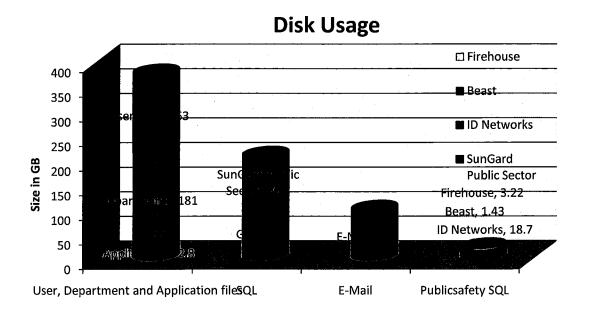

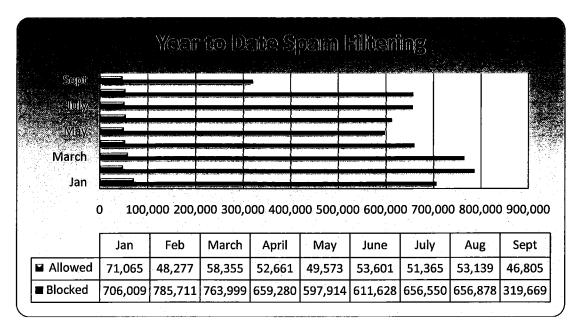

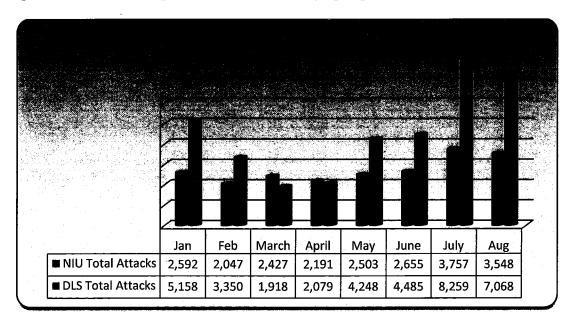


Virus and Spam Report
