AN ORDINANCE GRANTING A SPECIAL USE AND VARIATIONS TO HANDELSEN PRODUCTEMAATSCHAPPIJ DESHOUW BV (OWNER) AND AMERICA'S BAR AND GRILL (TENANT), IN THE BARRINGTON SQUARE MALL, 2308 W. HIGGINS ROAD, HOFFMAN ESTATES, ILLINOIS

WHEREAS, the Zoning Board of Appeals, at a public meeting duly called and held according to law on October 19, 2010, considered the request by Handelsen Productemaatschappij Deshouw BV, the owner of record of property legally described on Exhibit "A" and attached hereto and made a part hereof, on behalf of America's Bar and Gill (tenant), for a special use and variations from the Zoning Code to permit the operation of a game room, restaurant on the property located in the Barrington Square Mall at 2308 W. Higgins Road; and

WHEREAS, the Zoning Board of Appeals made certain Finding of Fact attached hereto and made a part hereof as Exhibit "B" and recommended approval of a special use and variations to the Board of Trustees; and

WHEREAS, it appears that there are particular hardships and unique circumstances from the application of the strict letter of the Zoning Ordinance to the property in question and that the proposed special use and variations have met the standards of 9-1-18-I and 9-1-15-C of the Hoffman Estates Municipal Code; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

Section 1: There be granted a special use under Section 9-8-2-B-2 to Handelsen Productemaatschappij Deshouw BV (owner) and America's Bar and Grill (tenant) to permit a Game Room, Restaurant on the property located at 2308 W. Higgins Road.

Section 2: That there be granted variations under Sections 9-2-1 and 9-8-2-B-2 to Handelsen Productemaatschappij Deshouw BV (owner) and America's Bar and Grill (tenant) to permit a maximum of fifteen (15) amusement devices in a Game Room, Restaurant containing 6,800 square feet in area and a seating bar for alcoholic beverages, instead of the minimum required 10,000 square feet in area and the requirement for no seating bar for alcoholic beverages.

Section 3: This special use is subject to the condition that all games shall be located within the restaurant building except that bag toss games shall be permitted outside in the mall courtyard only within an area approved by the Village through the site plan review process.

<u>Section 4</u>: The Village Clerk is hereby authorized to publish this ordinance in pamphlet form.

Section 5: This Ordinance shall be in full force and effect immediately from and after its passage and approval.

<u>PETITION:</u> Hearing held at the request of Handelsen Productemaatschappij Deshouw BV (Owner) and America's Bar and Grill (Tenant) to consider a special use and variations to permit the operation of a game room, restaurant on the property located at 2308 W. Higgins Road.

DISTRICT IN WHICH PROPERTY IS LOCATED: B-2, Community Business District

ZONING CODE SECTION(S) FOR SPECIAL USE: 9-8-2-B-2

ZONING CODE SECTION(S) FOR VARIATION: 9-2-1 and 9-8-2-B-2

<u>FINDING-OF-FACT</u>: The Zoning Board of Appeals (ZBA) found that the Standards for a Special Use (9-1-18-I) and Variation (9-1-15-C) were met.

MOTION: Request to grant Handelsen Productemaatschappij Deshouw BV (Owner) and America's Bar and Grill (Tenant) at 2308 W. Higgins Road, a special use under Section 9-8-2-B-2 of the Zoning Code to permit a Game Room, Restaurant and a variation under Sections 9-2-1 and 9-8-2-B-2 of the Zoning Code to permit a maximum of fifteen amusement devices in a Game Room, Restaurant containing 6,800 square feet in area and a seating bar for alcoholic beverages, instead of the minimum required 10,000 square feet in area and the requirement for no seating bar for alcoholic beverages.

<u>RECOMMENDATION</u>: The Zoning Board of Appeals (ZBA) recommends approval of this request.

The Petitioner is the owner of the establishment. He is requesting permission to allow games in this facility. The Petitioner stated that there will be no gambling done on these games, rather the games will be an added entertainment feature of his place. The type of games the Petitioner is proposing are not, in any way, games where the main focus is gambling. The Petitioner is proposing to add pool tables, dart boards and bag games to his establishment to enhance customer experience and draw in more customers during the daytime and early evening hours. These games will offer customers some relaxing and fun entertainment while they patronize the establishment during the lunch time hours and early evening hours.

The Petitioner stated that due to the economic times being what they are, he has had to modify his business to include televisions for patrons to watch sports as a draw to his establishment. He is changing to keep up with other similar businesses in order to draw customers in and keep them coming back.

The Zoning Board had considered limiting the bag games to inside only, but upon further discussion concluded that since these types of games are most often played outside in the warmer months, that allowing them to be outside on the Petitioner's patio during warmer months would be acceptable, and inside the establishment during more inclement or colder weather.

It is the recommendation of the Zoning Board to approve this request.

*STAFF NOTE (Outdoor Activities):

The petitioner's plan indicated that all games would be located within the building and there were no games shown outside. However, when the Zoning Board members discussed the possibility of adding a condition requiring all games to be indoors, the petitioner made it clear that his intention is to place the bag toss games somewhere outside in the mall courtyard during the summer months. A majority of the Zoning Board was supportive of allowing the games outside. It is clear that the bag toss games would be placed outside of the limits of the defined patio area that was specifically defined in the July 2007 Village Board site plan approval and therefore would violate a condition of that site plan approval.

In order for the petitioner to place bag toss games in the mall courtyard, outside of the patio area defined in the July 2007 site plan approval, a site plan amendment must first be reviewed by the Village and approved.

**STAFF NOTE (Number of Amusement Devices): The written request and plans submitted only include 10 amusement devices, however, verbally prior to the meeting the petitioner expanded his request to a total of 15 games to allow flexibility for expansion in the future. The Zoning Board of Appeals action included a total of 15 games based on the petitioner's verbal amendment of the request.

For this request, an interpretation was made that one set of bag boards would together constitute one single "amusement device" because they function together. The current code section on amusement devices was drafted many years ago, before this particular game was commonly used.

A RESOLUTION AUTHORIZING THE EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF HOFFMAN ESTATES AND THE O'HARE NOISE COMPATIBILITY COMMISSION

WHEREAS, the City of Chicago ("City") is a home rule municipality pursuant to Article VII, Section 6 of the 1970 Illinois Constitution (the "Illinois Constitution"), and, as such, may exercise any power and perform any function related to its government and affairs; and

WHEREAS, the City owns and operates an airport known as Chicago O'Hare International Airport (the "Airport"); and

WHEREAS, pursuant to authority granted by an ordinance adopted by the Chicago City Council on October 30, 1996, and Section 10 of Article VII of the Illinois Constitution and the Intergovernmental Cooperation Act (5 ILCS 220), the City entered into an Intergovernmental Agreement Relating to the O'Hare Noise Compatibility Commission (the "Intergovernmental Agreement") by and among the City and various municipalities and public school districts (as defined in the Intergovernmental Agreement, "Participants"); and

WHEREAS, the O'Hare Noise Compatibility Commission ("ONCC") was established pursuant to the Intergovernmental Agreement and provides a common forum for interested parties to have a voice in noise issues related to the Airport; and

WHEREAS, by its terms, the Intergovernmental Agreement became effective in November of 1996 and the term was extended from December 31, 2005 to December 31, 2010; and

WHEREAS, the Village of Hoffman Estates is currently a member of the O'Hare Noise Compatibility Commission; and

WHEREAS, ONCC has indicated a desire to enter into a new Intergovernmental Agreement; and

WHEREAS, the City of Chicago has approved a new Intergovernmental Agreement which is attached to this Resolution as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

<u>Section 1</u>: That the recitals set forth above are incorporated herein by reference as the factual basis for this transaction.

<u>Section 2</u>: That the Village President is hereby authorized to execute, and the Clerk to attest, the approval of the attached Intergovernmental Agreement between the O'Hare Noise Compatibility Commission and the Village of Hoffman Estates.

Section 3: That this Resolution shall be in full force and effect from and after its passage and approval according to law.
