II. Approval of Minutes

Motion by Trustee Pilafas, seconded by Trustee Stanton, to approve the Planning, Building & Zoning Committee meeting minutes of July 23, 2012. Voice vote taken. All ayes. Motion carried.

NEW BUSINESS

1. Request by Icon Building Group (owner) for a site plan amendment to construct a house on the vacant Lot 3 of the O'Malley Farm Subdivision at 930 Freeman Road.

An item summary from Peter Gugliotta and Josh Edwards was presented to Committee.

Mr. Gugliotta provided background on the project and the request.

Trustee Kincaid and Mr. Gugliotta discussed whether it would be beneficial to the project if the adjacent O'Malley house was demolished and determined that it would not impact this project. Trustee Kincaid and Mr. Gugliotta also discussed that the Village's code department does periodically check the exterior of the O'Malley house property.

Motion by Trustee Pilafas, seconded by Trustee Stanton, to approve the request by Icon Building Group (owner) for a site plan amendment to construct a house on the vacant Lot 3 of the O'Malley Farm Subdivision at 930 Freeman Road. Voice vote taken. All ayes. Motion carried.

2. Request by ADP Dealer Services for approval of an Economic Incentive Agreement.

An item summary from Jim Norris, Art Janura, Mark Koplin and Michael DuCharme was presented to Committee.

Trustee Kincaid and Mr. Gugliotta discussed how ADP managed to get extra parking spaces on their property. Trustee Pilafas and Mr. Gugliotta discussed that this extra parking may reduce street parking on Hassell Road depending on ADP's business operations. Trustee Mills and Mr. Koplin discussed that there were not any requirements regarding the number of employees in order for ADP to receive the incentive.

Motion by Trustee Stanton, seconded by Mayor McLeod, to approve request by ADP Dealer Services for approval of an Economic Incentive Agreement. Voice vote taken. All ayes. Motion carried.

3. Request approval of North West Housing Partnership as subrecipient to administer the Community Development Block Grant (CDBG) Single-Family Rehabilitation Project and to approve execution of the proposed Subrecipient Agreement.

An item summary from Peter Gugliotta was presented to Committee.

Mr. Gugliotta explained that this agreement was the same as last year's agreement. Trustee Mills and Mr. Gugliotta discussed that ability of North West Housing Partnership to assist more homeowners was contingent on the ebb and flow of the financing process. Trustee Kincaid and Mr. Gugliotta discussed additional opportunities to assist more homeowners, including using an emergency fund.

Motion by Trustee Pilafas, seconded by Mayor McLeod, to approve of North West Housing Partnership as subrecipient to administer the Community Development Block Grant (CDBG) Single-Family Rehabilitation Project and to approve execution of the proposed Subrecipient Agreement. Voice vote taken. All ayes. Motion carried.
