1. Request authorization for additional funding for Contractual Ash Tree Removals and Contractual Parkway Tree Trimming, in an amount not to exceed \$60,000.

Joe Nebel and Kelly Kerr submitted Committee Agenda Item.

Trustee Kincaid and Joe Nebel discussed the pace of tree replacements due to the Emerald Ash Borer infestation. Mr. Norris explained that the spread of Emerald Ash Borer was exacerbated by the drought.

Trustee Stanton and Mr. Nebel discussed that at the beginning of the Emerald Ash Borer infestation, there were 5,900 ash trees on village parkways and public spaces. Mr. Nebel explained that there were approximately 400 trees affected by Emerald Ash Borer to date.

Motion by Mayor McLeod, seconded by Trustee Green, to authorize additional funding for Contractual Ash Tree Removals and Contractual Parkway Tree Trimming, in an amount not to exceed \$60,000. Voice vote taken. All ayes. Motion carried.
