II. Approval of Minutes

Motion by Trustee Stanton seconded by Trustee Green, to approve the Public Works & Utilities Committee meeting minutes of January 28, 2013. Voice vote taken. All ayes. Motion carried.

1. Request by Ryland Homes for approval to extend the expiration date of the Shoe Factory Lift Station and Force Main Recapture Ordinance.

An item summary sheet from Gary Salavitch was presented to the Committee.

Motion by Trustee Gary Stanton, seconded by Mayor McLeod, to approve an ordinance extending the expiration date of the Shoe Factory Lift Station and Force Main Recapture. Voice vote taken. All ayes. Motion carried.

2. Request approval for the Historical Sites Commission to proceed with 2013 budgeted activities and events in an amount not to exceed \$1,250.

An item summary sheet from Joe Nebel and Paul Petrenko was presented to the Committee.

Motion by Trustee Stanton, seconded by Mayor McLeod, for Historical Sites Commission to proceed with 2013 budgeted activities and events in an amount not to exceed \$1,250. Voice vote taken. All ayes. Motion carried.

3. Request authorization to extend 2011 contract for 2013 parkway tree planting program to St. Aubin Nursery, Kirkland, IL (low qualifying bid) in an amount not to exceed \$134,250.

Motion by Trustee Stanton, seconded by Trustee Green, to authorize extension of 2011 contract for 2013 parkway tree planting program to St. Aubin Nursery, Kirkland, IL (low qualifying bid) . Voice vote taken. All ayes. Motion carried.

4. Request authorization to extend 2012 contract for 2013 season landscape maintenance services for Village owned sites, State rights-of-way, detention areas and park type properties to Alaniz Group, Elgin, IL (low qualifying bid), in an amount not to exceed \$85,000.

An item summary sheet from Joe Nebel and Kelly Kerr was presented to the Committee.

Motion by Trustee Green, seconded by Trustee Stanton, to extend 2012 contract for 2013 season landscape maintenance services for Village owned sites, State rights-of-way, detention areas and park type properties to Alaniz Group, Elgin, IL (low qualifying bid) in an amount not to exceed \$85,000. Voice vote taken. All ayes. Motion carried.

5. Request authorization to extend 2011 contract for 2013 weed control and fertilization, for various Village owned sites and rights-of-way to Spring Green, Plainfield, IL (low qualifying bid) in an amount not to exceed \$12,720.

An item summary sheet from Joe Nebel and Kelly Kerr was presented to the Committee.

Robert Steinberg, 4158 Portage Lane, addressed the Committee and asked whether the applications were liquid or dry materials. Mr. Nebel responded that three (3) different products are used and two were liquid herbicides and one was a dry fertilizer. Dr. Steinberg asked whether the Village needs to control weeds on its properties when the community does not and is allowed to have weeds grow as high as 12 inches. He asked about the environmental impact of

lawn services in town and that fertilizing is a waste of money if it is not watered. Mayor McLeod suggested that the Sustainability Commission look into this issue.

Trustee Kincaid inquired about different internet sites that would advertise and reach more bidders. Mr. Norris indicated that staff will look into free sites or industry sites that would advertise our bids.

Motion by Trustee Green, seconded by Trustee Stanton, to extend 2011 contract for 2013 weed control and fertilization for various Village owned sites and rights-of-way to Spring Green, Plainfield, IL (low qualifying bid) in an amount not to exceed \$12,720. Voice vote taken. All ayes. Motion carried.

6. Request authorization to extend 2011 contract for 2013 water/sewer concrete site restoration to Strada Construction Co., Addison, IL (low qualifying bid) at a unit price of \$8.47 per square foot for sidewalk, \$33 per lineal foot for curb and \$73 per square yard for driveway apron replacements in an amount not to exceed \$48,700.

An item summary sheet from Joe Nebel and Hailing Xiao was presented to the Committee.

Motion by Trustee Mills, seconded by Trustee Stanton, to extend 2011 contract for 2013 water/sewer concrete site restoration to Strada Construction Co., Addison, IL (low qualifying bid) at a unit price of \$8.47 per square foot for sidewalk, \$33 per lineal foot for curb and \$73 per square yard for driveway apron replacements in an amount not to exceed \$48,700. 7. Request authorization to award contract for purchase of fifteen (15) complete Mueller fire hydrants to H.D. Supply, Carol Stream, IL (low qualifying bid), in an amount not to exceed \$42,000.

8. Request authorization to award contract for 2013 water/sewer parkway landscape restoration to TNT Landscaping, Elgin, IL, at a unit price of \$7.25 per square yard for sodding and \$4 per square yard for seeding, in an amount not to exceed \$30,000.

Motion by Trustee Green, seconded by Trustee Mills, to award contract for 2013 water/sewer parkway landscape restoration to TNT Landscaping, Elgin, IL, at a unit price of \$7.25 per square yard for sodding and \$4 per square yard for seeding, in an amount not to exceed \$30,000. Voice vote taken. All ayes. Motion carried.
