4. NEW BUSINESS - PUBLIC HEARING - REQUEST OF MORIZZO FUNERAL HOME FOR AN AMENDMENT TO A SPECIAL USE UNDER THE ZONING CODE TO PERMIT A LIVE-IN CARETAKER ON THE PREMISES AT 2550 HASSELL ROAD (NORTHWEST CORNER OF HASSELL ROAD AND PEMBROKE AVENUE).

Commissioner Caramelli commented that he visited the funeral home and a live-in caretaker is common in the funeral business. The living space for the resident was clean and large.

Mr. Morizzo stated that the basement was supposed to be smaller than it was and had to change the floor plan based on heating and energy. Up the stairwell, there is a door leading outside. Across the hall there is another set of stairwells that lead out into the back vestibule which would lead one outside.
