7. PLANNING & ZONING COMMISSION REPORT

A. Request by RMS Properties, Inc. (owner), Berengaria Development, LLC (agent) and Goodwill Industries of Southeastern Wisconsin and Metropolitan Chicago (tenant) for a special use under Section 9-8-2-C-8 of the Zoning Code for a resale shop and donation center (Goodwill) and a site plan amendment on the property located at 2531-2545 Golf Road (Hoffman Village Shopping Center), with 14 conditions (see packets).
