The proposed construction consists of placement of approximately 710 feet of 18-inch diameter (cast iron pipe) and 330 feet of 36-inch diameter (RCP) sanitary sewer manhole-to-manhole lining with cured-in-place pipe (CIPP); coating two sanitary sewer manholes using a cement grout mixture followed by an epoxy based coating; coating three manholes using a three part liner system, bypass pumping, and other miscellaneous items of work.
