1. Request by Gill Management, Inc. for a courtesy review of a proposed Burger King on the southeast corner of Barrington and Higgins Roads.

Trustee Vandenbergh recused herself from this item due to working for the architect on record for this project.

Troy Triphahn and Ryan Triphahn, representing Corporate Design & Development Group and W-T Engineering, addressed the Committee and reviewed proposed plan for a Burger King at the southeast corner of Barrington and Higgins Road. The site is .52 acres and they are proposing to add a 3,081 square foot Burger King with a drive-thru and 26 parking stalls. The proposed site has parking issues, detention issues and environmental issues that would need to be addressed. They would be asking for several waivers from the Code as well for landscaping.

The Committee had several questions including handicapped parking stalls, height of retaining walls, water run-off and stacking of cars in the drive-thru.

2. Request approval of a resolution to enter into a Memorandum of Understanding with the Cook County HOME Investment Partnerships Program (HOME) consortium.

An item summary sheet from Ashley Monroe was presented to the Committee.

Ashley Monroe addressed the Committee and provided information regarding this consortium. She assured the Committee that in joining the consortium, there would be no change to the Village's existing CDBG program or funding allocation. The consortium would be for a 3-year period and funds can be used for a variety of projects including housing development or housing assistance and support.
