After including these receipts and disbursements, the balance of cash and investments for the operating funds is 29.0 million. For all of the Village funds, cash receipts and transfers-in exceeded cash disbursements and transfers-out by \$11,643,325, primarily due to property tax receipts. Overall, the total for cash and investments for all funds increased to \$186.3 million.
