1. Review of request for No Parking at 2490 Pembroke Avenue.

Mr. Weesner addressed the Committee and reported that the Transportation Division was contacted by S. Himmelstein and Company at 2490 Pembroke Avenue, regarding vehicles parked on Pembroke Avenue too close to their driveways which makes it impossible for trucks to access their parking lot and loading dock.

Mayor McLeod asked if this company is a 24-hour operation and that there may be a need for vehicles to park on the street when there is a large funeral at Morrizzo's. Ms. Geraldine Shamoon, Purchasing Manager for S. Himmelstein and Company, addressed the Committee and stated that their dock is open Monday through Fridays from 7 a.m. to 3:30 p.m. and would not need any restrictions during any other times. The Committee indicated that the ordinance should be changed to indicate no parking during the hours of 6 am to 4 pm Monday through Fridays only.

Motion by Trustee Pilafas, seconded by Trustee Gaeta, to amend the motion to include no parking during the hours of 6 am to 4 pm Monday through Fridays only. Voice vote taken. All ayes. Motion carried.

Motion by Trustee Mills, seconded by Mayor McLeod, to approve the amendment to the motion to approve an ordinance for no parking at 2490 Pembroke Avenue during the hours of 6 am to 4 pm Mondays through Fridays only. Voice vote taken. All ayes. Motion carried.

Trustee Pilafas requested that staff investigate bringing back Pace route along Higgins Road.
